The 2020 Presidential election results will be remembered as one of the most contested in American history. Even though there is overwhelming evidence that cheating went on in Arizona, Georgia, Michigan, Nevada, Pennsylvania, and Wisconsin, each of those State Legislatures has certified their Presidential election results. The Electoral College met and voted. State Governors have certified the results and sent them to Congress.

The final step of the Presidential election is on January 6th. If both chambers vote for the objection, it is my understanding that the electoral votes of that State must be thrown out. If the two chambers disagree the States electoral votes must be counted.

Most people believe that this is the last hope for President Trump to remain President. Once Congress certifies the Electoral College votes, I don't see another way to stop former Vice President Biden from becoming President.

So, what can you do to stop Joe Biden from taking office? First you can go to <https://everylegalvote.com/home>. Next you can write to your Congressman and Senators, and tell them to make an objection as written in 3 U.S. Code Sec.15. You can also send your representative a link to the Navarro Report. At the bottom of this message are the names and addresses of our Senators and the CD-3 Congressman.

Fourth, write to your friends in other Congressional Districts. Ask them to write to their Congressperson to demand he/she votes for the objection.

If the fraud of the 2020 election is not overturned, and the cheaters are not held responsible, our Nation as we know it will be one step closer to destruction.



World War II on the Home Front

December 7th is Pearl Harbor Remembrance Day. On that date widespread mobilization began immediately after the Japanese attack on Pearl Harbor in 1941 taking a total of 15 million men into the Armed Forces.

The period of American involvement in WWII was a time of enormous sacrifice for the American people. The public was asked to endure unprecedented hardships, including rationing of food, gas, rubber, metal, and other supplies. The war would leave a profound mark on American society and helped to set the stage for many of the social changes that accelerate in the 1950s and 60s.


At home, the war placed huge demands on American workers. To fill the jobs left vacant by men who joined the Armed Forces, many women entered the workforce for the first time.

Another change for the American women at that time--Congress allowed women to join the regular US Army for the first time. Although they did not serve in combat roles, 16 women were killed in action during the war and 83 were taken prisoner.

The demand for labor in the North also fueled the migration of African-Americans out of the South, a demographic shift known as the "Great Migration."

The effect of WWII on race relations was far-reaching. Wartime required whites and African-Americans to work and fight alongside each other to an unprecedented degree. At home, many Americans became painfully aware of the deep contradiction of fighting bigotry abroad while permitting Jim Crow segregations in the United States.

The experience of the war helped plant the seeds on the civil rights and feminist movements, which would gain force in the second half of the twentieth century. We benefit today from the social changes initiated on the home front in WWII.





Legislative Report

WASHINGTON, Zach Montague — The \$900 billion stimulus bill that President Trump finally signed into law on Sunday evening goes well beyond providing the \$600 checks that became a huge sticking point in getting the legislation across the finish line.

The relief package casts a wide net with a variety of measures aimed at addressing the needs of millions of Americans, including those who have lost their jobs, as well as small businesses, nursing homes, colleges, universities and K-12 schools.

The package extends some provisions of the original stimulus package that was passed in the spring, while adding new measures to help working families who have continued to suffer amid the pandemic.

The full text of the bill ran almost 5,600 pages. Here's a look at what's included.

Individual payments

Among the most anticipated components of the legislation is the direct payment, with \$600 going to individual adults with an adjusted gross income of up to \$75,000 a year based on 2019 earnings. Heads of households who earn up to \$112,500 and a couple (or someone whose spouse died in 2020) who make up to \$150,000 a year would get twice that amount.

Eligible families with dependent children would receive an additional \$600 per child.

In a change from the last round, payments will not be denied to citizens married to someone without a social security number, allowing some spouses of undocumented immigrants to claim the benefit this time around.

Unemployment benefits

With millions of Americans still unemployed, Congress acted to extend multiple programs to help those out of work, albeit at less generous levels than in the spring.

The agreement would revive enhanced federal jobless benefits for 11 weeks, providing a lifeline for hard-hit workers until March 14. The new benefit, up to \$300 per week, is half the amount provided by the original stimulus bill in the spring.

The legislation also extends Pandemic Unemployment Assistance — a program aimed at a broad set of freelancers and independent contractors — for the same period, providing an additional \$100 per week.

Education resources

School budgets have been severely crippled by the pandemic and left some of the most vulnerable students in dire academic and financial straits. The bill provides \$82 billion for education, including about \$54 billion for K-12 schools and \$23 billion for colleges and universities.

While the package provides far more money for K-12 schools than the first stimulus bill in March, the funds still fall short of what both sectors say they need to blunt the effect of the pandemic. Many school districts that transitioned to remote learning this year were forced to make expensive adjustments to accommodate students while often shedding staff to balance their budgets. Colleges and universities are also facing financial constraints amid rising expenses and falling revenue.

"The money provided in this bill will provide some limited relief, which is welcome news to struggling students and institutions. But it is not going to be nearly enough in the long run or even the medium term," Ted Mitchell, president of the American Council on Education, said in a statement.

Funding for broadband infrastructure

The legislation includes \$7 billion for expanding access to high-speed internet connections, nearly half of which will go toward helping cover the cost of monthly internet bills by providing up to \$50 per month to low-income families.

The deal also sets aside \$300 million for building out infrastructure in underserved rural areas and \$1 billion in grants for tribal broadband programs.

Targeted aid for small businesses

The agreement sets aside \$285 billion for additional loans to small businesses under the Paycheck Protection Program, renewing the program created under the initial stimulus legislation.

The latest version includes stricter terms that appear intended to correct some of the unpopular elements of the original program. It caps loans at \$2 million and makes them available only to borrowers with fewer than 300 employees that experienced at least a 25 percent drop in sales from a year earlier in at least one quarter. The agreement also sets aside \$12 billion specifically for minority-owned businesses. And publicly traded companies will be ineligible to apply this time around.

Funding for vaccines and nursing homes

The legislation sets aside nearly \$70 billion for a range of public health measures, including \$20 billion for the purchase of vaccines, \$8 billion for vaccine distribution and an additional \$20 billion to help states continue their test-and-trace programs.

The bill also allows a federal program that insures mortgages for nursing homes to dole out emergency loans aimed at helping hard-hit elder care centers.

Help for child care

The bill provides \$10 billion for the child care industry, with those funds intended to help providers struggling with reduced enrollment or closures stay open and continue paying their staffs. The funds are also supposed to help families struggling with tuition payments.

Support for climate measures

In an unusual rebuke of the Trump administration's climate policy, the deal includes new legislation to regulate hydrofluorocarbons, the powerful greenhouse gases common in air-conditioners and refrigerators.

It also allocates \$35 billion to fund wind, solar and other clean energy projects.

A ban on surprise medical bills

The package will also help millions of Americans avoid unexpected — and often exorbitant — medical bills that can result from visits to hospitals.

The bill makes it illegal for hospitals to charge patients for services like emergency treatment by out-of-network doctors or transport in air ambulances, which patients often have no say about.

Rental protections

The compromise would protect tenants struggling with rent by extending a moratorium on evictions for another month, through Jan. 31. The Department of Housing and Urban Development separately issued a similar moratorium on Monday that protects homeowners against foreclosures on mortgages backed by the Federal Home Administration. It runs until Feb. 28.

Food security

Expanding one of the most reliable channels of aid, the agreement increases monthly food stamp benefits — known as the Supplemental Nutrition Assistance Program, or SNAP — by 15 percent for six months, beginning on Jan. 1.

The overall legislation provides \$13 billion for increased nutrition assistance, \$400 million of which will support food banks and food pantries. An additional \$175 million is earmarked for nutrition programs under the Older Americans Act, such as Meals on Wheels.

- **Will I receive another stimulus payment?** Individual adults with adjusted gross income on their 2019 tax returns of up to \$75,000 a year will receive a \$600 payment, and a couple (or someone whose spouse died in 2020) earning up to \$150,000 a year will get twice that amount. There is also a \$600 payment for each child for families who meet those income requirements. People who file taxes using the head of household status and make up to \$112,500 also get \$600, plus the additional amount for children. People with incomes just above these levels will receive a partial payment that declines by \$5 for every \$100 in income.
- **When might my payment arrive?** The Treasury Department said on Dec. 29 that it had started making direct deposit payments, and would begin to mail checks the next day. But it will be a while before all eligible people receive their money.
- **Does the agreement affect unemployment insurance?** Lawmakers agreed to extend the amount of time that people can collect unemployment benefits and restart an extra federal benefit that is provided on top of the usual state benefit. But instead of \$600 a week, it would be \$300. That will last through March 14.

I am behind on my rent or expect to be soon. Will I receive any relief? The agreement will provide \$25 billion to be distributed through state and local governments to help renters who have fallen behind. To receive assistance, households will have to meet several conditions: Household income (for 2020) cannot exceed more than 80 percent of the area median income; at least one household member must be at risk of homelessness or housing instability; and individuals must qualify for unemployment benefits or have experienced financial hardship — directly or indirectly — because of the pandemic. The agreement said assistance will be prioritized for families with lower incomes and that have been unemployed for three months or more.

Blue State Blues: Rush Limbaugh Reminds Us That Americans Never Give Up

Conservative talk radio pioneer Rush Limbaugh delivered an emotional monologue on December 23, his last broadcast of 2020. His message: no matter how bleak things look, Americans never give up, because have faith in the power of freedom.

Limbaugh was reacting, in part, to the grim holiday message President-elect Joe Biden issued the day before. “Here is the simple truth: our darkest days in the battle against COVID are ahead of us, not behind us,” Biden told Americans.

To Limbaugh, who received a diagnosis of terminal lung cancer earlier this year, that kind of pessimism was unacceptable:

“[I]f I were president-elect of the country, it’s the last thing I would say. Even if I believed it, I doubt that I would put it this way. But I don’t believe this anyway. Our darkest days are ahead of us? What a bleak way of looking at things. ... We Americans have adapted to our problems. ... Our freedom has allowed our adaptability. If disaster is coming our way, we don’t just sit there and endure it. We come up with ways to avoid it, to beat it back, to overcome it, but we don’t just sit there and accept it. And, as such, we don’t just resign ourselves to the fact that they’re living in the darkest days because we, at least to this point, still have the greatest degree of freedom of any people on earth. Now, it’s under assault and under attack and we all know this. But I don’t believe our darkest days are ahead of us. I never have. People have been asking, “You’ve always told us you’d tell us when it’s time to panic. Is it time?” It’s never time to panic, folks. It’s never, ever gonna be time to give up on our country. It will never be time to give up on the United States. It will never be time to give up on yourself. Trust me.”

It is remarkable to hear a man who never expected to live to the end of the year talk about faith in the future. His words were more than a rebuke of Biden. They were timely counsel to conservatives who say Trump’s departure means America’s doom.

Limbaugh loves Donald Trump. He loves Trump because Trump is an outsider who achieved more in four years for America, and for the conservative cause, than any Washington politician has achieved in a lifetime. He loves Trump because Trump is the first Republican to stand up to the mainstream media, whom Limbaugh has identified for years as the real opponent of the American idea. Most of all, he loves Trump because he never gives up — not on himself, and not on the American people.

In recent weeks, Limbaugh has shared the suspicions of many Trump supporters that the 2020 election was fraudulent. “As far as they’re concerned, why shouldn’t they cheat? Why shouldn’t they do whatever it takes to win?” he asked on November 5.

“I mean, if there’s no cheating going on, if everything’s aboveboard and if Trump’s gonna lose and he’s gonna lose legitimately and you just better get your arms around it, why not let the Republicans in and let them see Trump losing legitimately? Why are they afraid of this?” he added, commenting on Democrats’ efforts to exclude Republican observers.

After the U.S. Supreme Court declined to hear the *Texas v. Pennsylvania* challenge on December 11, setting the stage for Biden to win the Electoral College vote three days later, Limbaugh told listeners that the fix was in: “This is strictly about getting rid of Donald Trump. There isn’t an entity in the American deep state, Washington establishment, whatever, that doesn’t want to get rid of Donald Trump, including enough justices on the Supreme Court. ... They want him gone.”

But Limbaugh counseled listeners not to give up fighting for the country. When a caller asked why voters should “bother” with the Georgia runoffs in January, Limbaugh replied: “If you lose these two seats, then it’s academic. There’s no way, you have no chance of stopping the Biden-Obama agenda. At least with these two, if they win, there is numerically a chance.”

Limbaugh’s career, spanning nearly five decades, is a story about never giving up. As he himself often recalls, he was fired from one radio job after another, and told he had no future in the business. But he was simply ahead of his time. The end of the so-called “Fairness Doctrine” and the deregulation of the airwaves inaugurated a new era of free speech. And that was when Limbaugh began to reach his audience: not just conservatives, but liberals dismayed at what their party was becoming.

As he expanded his reach, Limbaugh has inspired others to take up the cause. One was Andrew Breitbart, our founder, who recalled in his memoir, *Righteous Indignation: Excuse Me While I Save the World!*:

Limbaugh, like the professor I always wanted but never had the privilege to study under, created a vivid mental picture of the architecture of a world that I resided in but couldn’t see clearly: the Democrat-Media Complex. Embedded in Limbaugh’s analysis of politics was always a tandem discussion on the media. Each segment relentlessly pointed collusion between the media and the Democratic Party.

The 2020 election forced that collusion into the open — which, by now, includes the collaboration of the Silicon Valley tech giants. The censorship of the story of Hunter Biden’s laptop in mid-October, which proved that Joe Biden had lied about his knowledge of his family’s foreign business interests, will stand as one of the worst abuses in the history of American politics.



It will never be time to give up.




The Electoral College Didn't Protect Slavery

The presidential election in 2016 reminded Americans of the role played by the Electoral College in electing our president.

Proponents of abolishing or nullifying the Electoral College and replacing it with a direct-election scheme are trying to delegitimize the traditional process by claiming it is a remnant of America's racist past, created as part of the Founding Fathers' effort to protect slavery. The claim is completely false. The Founders did not create the Electoral College for the purpose of bolstering the power of slave states, nor did it have the effect of doing so.

The records of the Constitutional Convention plainly show that the Founders designed the Electoral College to keep the president independent of Congress, which would have selected the president under both the "Virginia Plan" and the rival "New Jersey Plan."

Direct election of the president wasn't seriously considered for several reasons, and it lost the few times delegates voted on the idea. Using electors to select the president was proposed several times during the convention by anti-slavery delegates such as Alexander Hamilton, Gouverneur Morris, and William Paterson. Opposition came largely from Southern delegates. When the convention passed an early version of the Electoral College in mid-July of 1787, only three states voted against it—Georgia, North Carolina, and South Carolina.

Delegates removed that version several days later and put congressional appointment of the president back in, but delegates remained concerned about the independence of the president.

In the end, the Electoral College won out over congressional appointment with only North Carolina and South Carolina voting against it.

It should be obvious that if delegates created the Electoral College as part of a scheme to bolster the power of the slave states, its proponents would not have been anti-slavery delegates and votes against it would not have come from slave states.

Some have argued that even if the Electoral College was not intended to strengthen the power of slave states, it nevertheless had that effect and helped to elect pro-slavery presidents because the three-fifths clause gave the slave states more representatives (and thus more electors).

History doesn't support this claim either. With one possible exception, the additional electors provided under the three-fifths clause didn't have a decisive role in any presidential election. The candidates who won the Electoral College in every election would have won without those electors.

The possible exception is the 1800 election for president, when Thomas Jefferson defeated incumbent John Adams. But it is impossible to know how the result might have differed without the three-fifths clause, because both Adams and Jefferson received enough electoral votes from slave states to affect the election. There's no way to know who would have prevailed without those electors.

What is known is that in 1824, the Electoral College prevented victory for Andrew Jackson, a staunch defender of slavery. Jackson received the most popular and electoral votes, but did not receive a majority of either.

The election was sent to the House of Representatives, which selected the anti-slavery candidate John Quincy Adams over Jackson.

Hamilton said of the Electoral College that if it was "not perfect, it is at least excellent."

Those who wish to abolish or nullify the Electoral College might want to start looking for any of its real imperfections to press their case, rather than ignoring history and trying to falsely tie it to the vile institution of slavery.

Dear Senator _____,

I request you exercise your Constitutional and statutory authority to object to the certification of any elector from any state that refuses to allow a meaningful audit of the November general election for electors to the Presidency, which must include : 1) a re-canvass of the vote that authorizes independent confirmation of a signature match using the same standards the same election officials use for nomination petitions, recall petitions and initiative petitions; 2) publishing of the ballots for the world to review and observe, as states promised when they wrote large taxpayer checks to election machine companies like Dominion and others; and 3) audited review of the voter rolls to insure only qualified voters cast ballots for electors to the Presidency. If a state refuses to allow an honest audit of the vote, then I request you object to the certification of any electors from that state which has refused such an audit. At present, this includes the electors from AZ, NV, NM, GA, WI, PA and MI.



It's for Mike Pence to Judge whether a Presidential Election Was Held At All

Ted Noel, December 206, 2020 for *American Thinker*

On January 6, a joint session of Congress will open with Vice President Pence presiding as president of the Senate. His power will be plenary and unappealable. You heard that right. As president of the Senate, every objection comes directly to him, and he can rule any objection "out of order" or "denied." His task will be to fulfill his oath of office to protect and defend the Constitution of the United States and to ensure that the laws be faithfully executed. This is a high standard of performance, and V.P. Pence will have two choices. He can roll over on "certified" electors, or he can uphold the law.

Article II, Section 1 of the Constitution gives state legislatures "plenary authority" as enunciated in *Bush v. Gore*. This is key, since the counting of votes is discussed in Article II, the 12th Amendment, and 3 USC 15. To this we must add the history of counting and objections recounted by Alexander Macris (here and here). Put bluntly, it's as clear as mud. Add to that the fact that the contested states of Arizona, Georgia, Michigan, New Mexico, Nevada, Pennsylvania, and Wisconsin have sent dueling slates of electors to D.C. This means that the V.P. has to decide how he will handle the situation when two sealed envelopes are handed to him from any of those states.

Macris points out that in 1800, *even with constitutional deficiencies in Georgia*, Thomas Jefferson blithely counted defective electoral votes from Georgia, effectively voting himself into the presidency. This demonstrates that the president of the Senate is the final authority on any motions or objections during the vote-counting. There is no appeal. That doesn't mean there won't be any outrage. Whatever Pence does, people will be angry. But what does the law demand?

Seven contested states clearly violated their own laws. Rather than list the facts, which have been detailed in multiple articles, we must consider the following:

An election is a process of counting votes for candidates. Only valid, lawful votes may be counted. A valid lawful vote is:

- Cast by an eligible, properly registered elector as prescribed by laws enacted by the state Legislature.
- Cast in a timely manner, as prescribed by laws enacted by the state Legislature.

Cast in a proper form as prescribed by laws enacted by the state Legislature.

Any process that does not follow these rules *is not an election*. Anything that proceeds from it cannot be regarded as having any lawful import.

Most commentators suggest that a process of collecting pieces of paper with marks on them is an election regardless of errors, omissions, and even deliberate malfeasance. This is a mistake. Imagine a golf tournament where every bad shot by one player gets a do-over, but the competing player has to follow USGA rules in detail. One player gets to drop freely out of hazards, but the other has to tackle every embedded ball as it lies. The result is a travesty.

The same thing applies to elections. If there are a handful of improper votes, we can suggest that there was in fact an election, perhaps tainted, but the election wasn't materially harmed. But when the people charged with managing the election decide to ignore the law, whatever process they supervise is not the process defined by the law. Therefore, it is not an election.

This leaves V.P. Pence with a dilemma. He is a gentleman who regards our governmental traditions with a degree of reverence, so he will be reluctant to take any bold action. But as an honorable man, faced with massive illegality, he must act to protect the law. Consider how things might go down as the two closed envelopes from Georgia are handed to the V.P. Rather than opening them, he says:

In my hand are envelopes purporting to contain electoral votes from Georgia. They are competing for consideration, so it is essential that I consider the law that governs this. That law, according to the Legislature of Georgia and Article II, Section 1 of the U.S. Constitution is the Georgia statute that includes procedures for signature-matching on absentee ballots, a requirement that all absentee ballots be first requested by a legitimate voter, and that election monitors be meaningfully present at all times while votes were counted.

The Georgia secretary of state, who is not empowered by the U.S. Constitution to make changes to election law, entered into a

Consent Decree that gutted these protections enacted by the Georgia Legislature. The processes that he prescribed and were ultimately followed were manifestly contrary to that law. Further, the State of Georgia, in unprecedented concert with other states, suspended counting of ballots in the middle of the night, covering its conspiracy with a false claim of a "water main break." We now know from surveillance video that many thousands of "ballots" were counted unlawfully in the absence of legally required observers.

Finally, the State of Georgia, under the authority of secretary of state Brad Raffensperger, a non-legislative actor, used fatally flawed Dominion voting machines that have been demonstrated to be unreliable. In testing, the error rate of Dominion machines has exceeded 60%, far in excess of legal limits. They are designed to facilitate fraud without creating the legally required paper trail. This alone is far more than enough to swing an election.

Since the state of Georgia has failed to follow the election law established by its legislature under Article II, Section 1 of the Constitution, it has not conducted a presidential election. Therefore, no "presidential electors" were appointed in Georgia. Further, "electors" "certified" by non-legislative actors pursuant to this process are in fact not "presidential electors." The competing slate of "electors" is similarly deficient, having not been elected through a presidential election.

Therefore, the chair rules that Georgia has not transmitted the votes of any presidential electors to this body. Georgia presents zero votes for Donald Trump and zero votes for Joseph Biden.


The central point is that the VP, as the presiding officer and final authority, has the unquestionable authority to declare that the states in question have not conducted presidential elections. There will be wailing and gnashing of teeth, but no one has the authority to override his decision.

The statement says nothing about who might or might not have "won" the contested states. Rather, by not following their own laws, as enacted by their own legislatures, they have violated Article II, Section 1. Thus, they have not conducted an election, and their results are void.

If the votes of all seven contested states are registered as zero, President Trump will have 232 votes, and Joe Biden will have 222. The 12th Amendment says, "[T]he votes shall then be counted[.] ... The person having the greatest number of votes for President, shall be the President[.]"

In plain language, Donald Trump will be re-elected, since he has a majority of the actual electoral votes. There will be no need to involve the House of Representatives to resolve a contingent election.

Richard Nixon chose not to contest the 1960 election because he felt that winning that way would lead to an ungovernable country. If V.P. Pence does this, that same argument might be made. But is the country governable even now? Blue states such as California, Oregon, Washington, New York, New Jersey, and Michigan are already operating in an openly lawless manner with their "emergency" "COVID-related" restrictions. Their denial of the civil rights of law-abiding citizens is horrific. Their refusal to do basic policing and law enforcement is a recipe for open war. How much worse would things be if the V.P. lived up to his oath and upheld the law?

Report: Fortune 500 CEOs Will Intervene if Joe Biden Isn't Inaugurated by January 20

Executives from Fortune 500 corporations say they are planning to intervene if Democrat Joe Biden is not inaugurated into office by January 20, 2021.

The CEOs decided to wait for the November 20 certification of votes in Georgia before meeting to decide their next moves. **Action could include threats to stop donations to political action committees or even corporate relocations,** Sonnenfeld said. [Emphasis added]

The big business lobby and Wall Street have been looking to undermine Trump's economic nationalist agenda for years. The U.S. Chamber of Commerce and the Business Roundtable — both representing some of the nation's largest multinational corporations and fighting Trump — congratulated Biden and Sen. Kamala Harris (D-CA) days after the November 3 election.

"The U.S. Chamber stands ready to work with the Biden administration and leaders on both sides of the aisle to restore public health, revitalize our economy, and help rebuild American lives and communities," the Chamber's statement reads.

The Ideological Stripe of Covid-19

An accelerant on all things the average Cultural Marxist holds dear

For some time I had been struggling with a conundrum: Why is it that Covid breaks down, more or less precisely into an ideological divide? This had been clear for a while in a kind of white-of-the-eye way before I began really to focus on it. Then it struck me: Had a 'pandemic' occurred when I was a feature writer and reporter with Irish newspapers about 20 years ago, I could not imagine attending editorial conferences in which the matter would be discussed as though implicitly a left-right question, or that the attitude towards it of those assembled for daily or weekly conferences would be predictable on that basis. Yet, this is more or less what has emerged.

From reports all over the world, it seems an almost universal principle that 'conservative' and 'right wing' interests, groupings and individuals are opposed to lockdown, and 'left-wingers' in favour of it. And this means that lefties are Covid believers, whereas conservatives tend more to be sceptics. In the United States, the pro-lockdown governors and mayors have all but invariably been Dems. The sceptics tend to be Republicans or 'alt-right' (whatever that is) bloggers and vloggers. Likewise, across Europe, the governments locking their peoples down most viciously and for long periods are those led by socialist parties, whereas the more relaxed countries — Sweden, a special case, aside — tend to be led by parties of the populist right. We have come to take this situation for granted, as though the reasons for it are self-evident. But, actually, there are not in the least clear. If Covid is, as many authorities insist, a health issue, why would it automatically break down in this manner? Why is the attitude of your neighbour predictable on political grounds? Why does someone's attitude to Covid predict so much else about him?

In part, I believe, it is because from the start there was this strong undercurrent that Covid was about something other than health. Almost nobody was — *is*, even — quite certain what the subtext is, but for some unaccountable reason almost everyone senses that it has something to do with the way the world has been breaking open in recent times, especially in the past five years or so, in ways that have been variously and exhaustively described and parsed, but really seem to boil down to a divide between people who have their showers in the evening and people who have them in the morning.

It may also, as with so many things these days, have something to do with Donald Trump. Although he moved with alacrity at the end of January to close down access to America from China, he was from the beginning a sceptic of the lockdown idea, repeatedly warning that the cure should not be 'worse than the disease.' This seems to have imposed a cleavage on American life, roughly dividing the country in half.

There was an interesting counter to this perspective. Around the time Trump began doing his nightly televised White House briefing sessions in early April, it was clear that the worst five US states for case numbers and deaths were all Democrat-run, and together accounted for two-thirds of total national Covid deaths. Of the worst ten states for fatalities, Democratic states accounted for in the region of 13 times the number of deaths as Republican-led states. On the percentage front (deaths as a percentage of cases — a statistically pointless but still revelatory metric) the top five states were all Democrat-run, with New York on top, followed by Louisiana, New Jersey, Michigan and Washington. After that, the figures began to shrink, falling into fairly level pegging between Democrat and Republican states. An American friend to whom I put these stats at the time offered this explanation: 'Globalists tend to be Democrats. Globalists tend to live in global hub cities. Global hub cities are nodes of virus transmission. It's where they jump from continent to continent. Thus concentration of cases in Democrat run states. (Louisiana is the outlier in this explanation.)'

Seven months later, the latest 'case' data indicate a more balanced league sequence and coloration pattern — California at the top, followed by Texas, Florida, Illinois and Georgia. The pattern with up-to-date deaths is interestingly slightly different, with Texas at the top, followed by California, Florida, New York and Illinois. The patterns of April have not maintained themselves, but perhaps those early figures created an impression of some kind that caused Covid to be seen in America as a tribal issue, with this interpretation rapidly being exported to the rest of the world.

There has been for a while a view abroad that Covid is and was essentially — from a timing viewpoint at least — directed at bringing an end to the Trump presidency. Although the list of alternative conspiracies is long, with many inter-connections, this view of things still has much to recommend it. I have three different and constantly shifting theories about Trump and the virus: 1. that he's bought into it as much as anyone; 2. that he's been captured by his medical team and cannot escape until re-election is under his belt; 3. that he has a cunning plan that he's about to spring at any moment. I'm leaning towards 3. at the moment. I think the prize of the second term is so vital to him and his cause that he cannot jeopardize it by calling our Fauci, Birs etc., who have clearly been trying from the start to slyly manage the virus in a manner designed to unseat President Trump. He knows it; they know he knows it; he knows they know he knows it, but he dare not rock the boat while things are as volatile as they are. There are some worrying things in some of his public statements about vaccines, but we will have to wait about ten days for the picture to become clearer.

For a time, the 'pandemic' did put Trump under pressure, even looking like it might indeed unseat the president, though that moment appears to have passed. The world's legacy media, which appear to despise Trump almost to the last journaliar, have taken to Covid like ducks to watermelon rind, lying through their face masks at every opportunity and in effect imposing on their audiences a form of mass entrancement impervious to truth, fact or stat.

Still, the truth comes tumbling out. As the figures for excess deaths in 2020 become solidified, it is emerging that this has been in no sense an exceptional year for fatalities almost anywhere, which means that there is no additional burden of death arising from Covid.

We also now know that more than 50% of deaths worldwide have occurred in care homes, and that most of these deaths were not caused by Covid but most likely arose from psychological stress due to media-generated panic among people nearing the end of their lives. (Those who doubt this explanation should read the studies and watch the videos of Canadian scientist Denis Rancourt.) There are also numerous as yet to be investigated concerns about the untested admission of people who subsequently emerged as infected into care homes during March. New York exhibited the most marked of such patterns, with the NY state governor Andrew Cuomo issuing on March 25 an order permitting nursing homes to readmit sick patients without testing them for Covid-19. Facing allegations regarding the underestimation of fatalities, Cuomo resisted pressure for more stringent reporting of Covid nursing home deaths, and also, in his annual budget, introduced a measure indemnifying New York hospitals, nursing homes and other healthcare facilities against liability for Covid-related deaths.

From the Covid-unrelated death in late May of George Floyd, the worldwide Black Lives Matter protests — again incongruously — seemed to jell as an intrinsic element of the Covid narrative. On its face, the idea made no sense, but the controversy concerning the differing attitudes of various authorities to BLM protests as against anti-lockdown demos effected an underscoring of the ideological pattern. Police officers who had been enthusiastically truncheoning Covid sceptics just the week before were to be seen taking the knee in public in tribute to America's latest and most dubious hero, and governors who had been coming down like hailstorms on Covid dissenters turned a blind eye to breaches by the masses of Woke warriors who took to the streets for the summer.

Even though it makes just a limited amount of sense, it does at this stage appear that, in some odd and irrational way, Covid is actually a left-wing phenomenon. This undoubtedly has to do with authority, indeed with the authoritarian tic that seems to afflict many leftists. It is not unreasonable to observe that, in general, when you scratch a progressive you uncover a fascist underneath, and this discovery is in no way discredited by the fact that said progressive will be calling *you* a fascist.

Covid, as has been seen everywhere, is an intensely authoritarian phenomenon. The first measures introduced by governments practically everywhere were directed not at protecting public health but awarding powers to themselves to restrict and coerce their citizens and impose draconian penalties for breaches or dissent. This kind of thing suits leftists just fine and dandy. Not only do they enjoy seeing the boots of the regime on the face of fellow citizens, but they themselves seem to enjoy, like masochists under the whip of the master, the lick of leather on their own hides.

There is, moreover, something fundamentally neurotic about the latest incarnation of the leftist in culture. Your average Cultural Marxist tends to be overanxious, ill-educated, resentful, hung-up and irrational. He or she, after all, believes in an ideology that makes little sense unless you behold the world in an intensely neurotic fashion, seeing everything as the culmination of a history that spent every waking moment trying to stitch up everything for patriarchy and Christians. The ends simply refuse to tie together, and your fellow human beings appear to be utterly oblivious to the things you learned for four years at college. Clearly, then, state coercion is essential to bringing the world to order and everyone else around to your view of things.

At a basic human level, the kinds of people who gravitate to left or right tend to divide also, generally speaking, in terms of physique, occupation, and mentality. Leftists, shall we say, tend less towards muscularity, work generally in offices, salons or cubicles, and think the world owes them a living, an expectation the world generally speaking appears to honour and come up, as it were, trumps on. They also consider themselves better educated, but in reality this means that they spent more time than others being indoctrinated with the virus that now afflicts their brains. I find it interesting that working class/blue collar people seem to see through Covid in a flash, whereas the average college graduate goes around in what appears a terrified trance thinking he's going to meet his death around every corner.

Covid has emerged, in one aspect of its operation, as an accelerant on all things the average Cultural Marxist holds dear: restrictions on practice of religion and public assembly, cycle lanes and other green stuff, compulsory face masks which make everyone as unattractive as the average blue-tinted Cultural Marxist, disincentives to voting in person, and so forth. It emphasizes the 'common good', which somehow reveals itself (who knew?) as extending to the state the right to restrict citizens as though self-evidently some kind of criminals on the mere possibility that they might be 'infected' with a non lethal disease. It has no regard for charter, proclamation or constitution. It does not care for family, nation or God — is, in fact, the enemy of all three.

On the other hand, Covid has none of what might be called 'right wing' characteristics. It seeks not to make America, or anywhere else, 'great again', but to destroy everything before it and grate on everyone's nerves until they surrender to the New World Order.


