Update from Coastside CERT

- Grant finalized
- 21 new CERTs
- Roster over 500
- 157 CERTS
- 60 HAMS
- More than 100 waiting for CERT training
- 85 waiting for HAM training
- Working on list of all CERTs trained since 1999 to ID credentials
- 9/14 skills refresher rodeo & BBQ
- new training format for CERT 1 & 2
 - o One day of classroom for 60 candidates (10/22)
 - o Two days of field exercises, 30 candidates each (10/26 & 11/2)
- 14 Multi-neighborhood meetings held, leads identified in 30
- El Granada is organizing by zones
- Highest priority is communication, FRS training in collaboration with HAM club
- Jim Holly is official trainer for ARES, new AWRL structure has 3 levels

DART Exercise – 10/26 10:00-1:00

- Will be coordinated regional exercise to simulate movement of supplies and people
- Coordinating with HAM club, Coastside Hope and Second Harvest
- Possible scenarios will be circulated
- Need volunteers. Coastside CERT can put information out for additional training and events like this that may be of interest, but anyone attending the offering is going as general public (some of which may have CERT training). This will not be an official CERT exercise and DSW will not be provided for any training exercise that is not approved by Kevin Rose in writing in advance.
- Pilots need to certify \$1M in personal insurance
- Statewide DART now provides \$2M in additional insurance for members who do not need to be affiliated with local chapters

CEOC Training update

- Still need to coordinate with county and city to stand up CEOC in the absence of City staff

Shelter Ops Update – Chris Orman

- Chris and Steve Stockman will lead Committee to be selected from list of existing volunteers
- Annual plan presented highlighting:
 - o Taking stock of existing supplies & trailers
 - o Interviewing key stakeholders
 - o Establishing procedures, MOU & streamlining
 - o Identifying trained volunteers & managers, including post on Nextdoor
 - o Establish regular training (TBD if Red Cross or FEMA formats)
 - o Reviewing existing MOU between Puente and School District
 - o Determining how many shelters are needed and inspecting locations
