THE REDUCTION OF LEAD IN DRINKING WATER ACT, ALSO REFERRED TO AS FEDERAL PUBLIC LAW 111-380 AMENDS THE SDWA TO REDUCE THE ALLOWABLE LEAD CONTENT OF THE WETTED SURFACES OF PLUMBING PRODUCTS TO A WEIGHTED AVERAGE OF 0.25% OR LESS, WHICH HAS AN EFFECTIVE DATE OF JANUARY 4, 2014.

THIS IS TO CERTIFY THAT ALL ROSS CONTROL VALVE CONFORMS TO THE HIGH QUALITY STANDARDS OF ROSS VALVE MFG. CO., INC. AND THE SWDA FEDERAL PUBLIC LAW 11-380.

ON JANUARY 4, 2014, FEDERAL PUBLIC LAW 111-380 (I.E. REDUCTION OF LEAD IN DRINKING WATER ACT) PROHIBITS THE SALE AND INSTALLATION OF PLUMBING PRODUCTS USED IN A POTABLE WATER APPLICATION WITH A WETTED SURFACE AREA CONTAINING MORE THAN A WEIGHTED AVERAGE OF .25% LEAD. ROSS VALVE HAS ELIMINATED THE USE OF BRONZE B62 WITHIN THE VALVE WETTED SURFACE AREA AND REPLACED IT WITH THE LEAD FREE BRONZE ASTM B584 AND B505 AND/OR STAINLESS STEEL COMPONENTS ASTM A743 GRADE CF8 AND CF8M

EXTENDED GUARANTEE: MATERIALS ARE GUARANTEED FREE FROM MECHANICAL DEFECTS WHEN SHIPPED FROM THE FACTORY. THE ROSS VALVE MFG. CO., INC. AGREES TO REPLACE F.O.B.
