

City of New Munich
City Council Minutes

April 2nd, 2018

The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Jim Poepping, Shawn Duevel, Pat Nathe, Ron Doll and Bryan Kasten were present.

On a motion by Ron Doll, seconded by Bryan Kasten and carried the minutes from March 5th, 2018 were approved.

Fire Chief, Allen Fiedler was present to inform the Council of 2 medicals calls last month. 1st Responder training was complete. Allen submitted bills that needs to be paid, Walmart \$51.41 & \$14.01, TMV Training \$2,250, Everything Signs \$215.89, Ramler Trucking \$36.00. He mentioned they are interested in purchasing a used truck from the City of Albany for \$5,000. He also mentioned they were interested in building another stall for the fire department, they were just getting ideas. He also brought a check that could be voided since the product was returned for \$845.48.

Waste/Water Operator, Tom Valerius was present to inform the Council that he finished the NM Meat Agreement and contract is good for 5 years. Tom did more water samples and we are waiting for all the test results to come back regarding the lead and fluoride.

On a motion by Shawn Duevel, seconded by Ron Doll carried the annual renewal of liquor licenses for Munich Hofbrau and Shady's Bar and Grill were approved.

Sandy Zierden brought a check in for a \$4,000 donation from the New Munich Jaycees and also brought a building permit that needed approval for Harold Klaphake which was approved by a motion by Ron Doll, seconded by Bryan Kasten. She also recommended that someone from the City Council should be attending the Planning and Zoning meetings which are held on the last Thursday of the month at 6:30, Bryan Kasten agreed to go.

Dave Bentrud is running for Sheriff and requested a couple minutes during the council meeting to speak with the council.

A motion was made by Pat Nathe, and seconded by Ron Doll to give permission to Stacy Funk the City Clerk to be a signer and get access to the Credit Union banking information.

On a motion by Pat Nathe, seconded by Shawn Duevel and carried the Application agreement from Country Club lawn service for \$339.86 was approved.

With the new rental licensing we like to sign a contract with Mark Harren from Mid-MN Code Enforcement, Inc., to inspect our rental properties in our city. A motion was made by Ron Doll and seconded by Bryan Kasten.

Tina Valerius owner of the Tree of Life Assisted Living asked if the City Hall would be their Alternative Care Site Temporary Shelter in case of an emergency, a motion was made by Ron Doll and seconded by Pat Nathe, a contract was signed.
