100 (ish) YEARS AGO
Board of Village Trustees, Cascade, ID

September 26, 1921
Whereas the Payette Forest ranger has granted the priviledge of damming a small lake on the west mountain by the Village of Cascade for the purpose of suppling the Village of Cascade with water also crossing the Forest with its ditches and pipes. Carried.

October 4, 1921
On motion that the clerk be instructed to find out what a concrete water tank at the intersection of mainstreet and _____ to hold fifty gallons or more for watering horses. Carried.

November 1, 1921
The estimate of W.H. Huff, for water at the intersecting of Main & Market streets. Motion that the chairman be authorized to make a contract with Mr. Huff, to put in the water fountain, complete a first class job, the same to be approved by The Village trustees. Carried.

Snow will soon be on the melt and those long awaited green shoots will begin to appear. Get a head start on weed abatement and yard care by making a plan for the upcoming season. Please keep conservation in mind.

Consider Alpine Xeriscaping. Use native, drought tolerant plants and recyclable hardscape materials.



Don't overfertilize your lawn. The more you fertilize, the more water you use. Be lean with the green.
