INSTRUCTIONS TO BIDDERS FOR VAC APRON AT SPACE COAST REGIONAL AIRPORT TITUSVILLE, FLORIDA

<u>Submittal Requirements:</u> Submit in Duplicate - Make Photocopies. Proposal, plus the bid form, plus the Bid Schedule, plus the executed Bid Bond with attachments (either the executed Bid Bond with required attachments, or a certified check in the amount of 5% of the bid), plus addenda acknowledgement sheets, before the time and date written below. Submit these documents in duplicate (one original and one photocopy.) It is not necessary to submit the entire specification book, or to attach addenda (only the addenda acknowledgement sheet(s). **Late submissions will not be considered.** The documents shall be submitted in a large-size sealed envelope, which shall bear the name of the Bidder and shall be clearly marked in large letters, "Bid for VAC APRON at the Space Coast Regional Airport." Bids (Proposals) may not be submitted by fax, e-mail, or in any other unsealed format in which the bid amount can be known prior to the bid opening. Bids or price quotations from subcontractor firms or suppliers, or for portions of the job, will not be considered.

<u>Opening of Bids:</u> The bids will be opened and read aloud in Airport Authority conference room, at the time and date stated above. Persons attending the Bid Opening will be given an opportunity to examine the submitted bid documents.

<u>Tabulation of Bids; Recommendation and Award of Contract; Duration of Bids:</u> The Engineer will prepare a tabulation of the prices bid for the various items and will e-mail the tabulation (as an Excel spreadsheet) if requested. Any mathematical errors in the schedule of prices bid will be corrected in the bid tabulation. If the apparent successful bidder is not well known to the Engineer and/or the Airport Staff, the Engineer will request that the bidder furnish detailed qualification information, including but not limited to a list of similar recent projects, project references with names and telephone numbers of Owner contacts, and financial information. For privacy reasons, it will be acceptable to present the financial information in a meeting with Airport staff, rather than submitting the information in
