
LET'S KEEP THAT MOMENTUM GOING



LEISURETIME BOARD MEETINGS 101

All meetings of the Board of Directors and LTRV Members are required to follow Roberts Rules of Order.

REGULAR BOARD MEETINGS

- Per current by-laws the Board of Director's are required to meet six (6) times a year. However, meeting more is acceptable.
- The Board prepares an agenda prior to their planned meeting.
- Lot owners have the right to and are encouraged to attend. Speaking at a regular board meeting requires prior Board approval to be added to the meeting agenda.
- The meeting discussion includes but is not limited to reviewing the financial statement, discussing unresolved issues, old business, new business and committee updates.
- Motions are made to approve the minutes from the prior meeting and the most current financial statement available. Other motions might be made to resolve old business or made to investigate new business.
- Regular board meetings do not allow for an open forum for lot owners to ask question or share concerns. However, if you think you have something that would be useful for the meeting you can contact the Board.
- Lot owners may also contact the Board with questions or share concerns in a letter or email.
- Questions may be answered and concerns resolved directly with the lot owner and/or discussed at a board meeting.

EXECUTIVE MEETINGS

- Executive Meetings are outlined in Section 3.10 of the Leisuretime RV Park By-Laws.
- Homeowner's association members are not allowed to attend these meetings unless they are to be part of the proceedings being discussed.

ANNUAL MEETING

- The HOA annual meeting is a general meeting for the entire HOA membership.
- Meeting agenda items may include committee presentations, election results, proposals that need member approval and discussion of projects.

WHAT'S TAKING SO LONG?

MEETING MINUTES

• The minutes from the meeting this month will be transcribed and presented at the next board meeting for approval before they are posted.

FINANCIAL STATEMENTS

- Bank statements are needed to reconcile financial statements.
- The board receives bank statements the month following the end of a 30-day bank cycle.
- The Board is only required to meet six (6) times a year.

EXAMPLE

Meeting Date: August 14, 2021

- Review June's Bank statement and Financial Report
- Review July meeting minutes.
- Motions made to approve.
- Notify communication chairperson to add approved documents to the web site and share in email to lot owners.
