POLICIES & PROCEDURES

Registration/Tuition

There is an annual registration fee of \$25.00 per child.

Tuition is auto-drafted on the 1st of each month. Accounts must be cleared by the 3rd of the month or a \$25.00 late fee will be automatically applied. **All tuition/fees are non-refundable**

ALL accounts must have bank account or credit / debit card information on file. It is the account holder's responsibility to make sure the account on file is current at all times. **NO CHECKS OR AMERICAN EXPRESS CARDS WILL BE ACCEPTED.**

Tuition will not be prorated due to missed class, shorter months, or Holidays.

Class Additions/Withdrawals

Class additions need to be in written notice (via email). Any additions made mid-month will be prorated and debited the same day the class is added.

To withdrawal your dancer from any (or all) classes, a written notice (via email) is required within **7 days** of the next billing cycle. **Once you have been billed for the current month, no credit/refund will be issued for withdrawing your dancer that month (extenuating circumstances will be taken into consideration).**

Your child's class level will be determined by the instructor. Upon enrollment, your child will be placed in the beginning level to be evaluated and placed accordingly by the instructor. **Dancers will ONLY move up when the instructor determines they are ready.**

Star Steppers has the right to combine/cancel a class or change the instructor at any time.

Studio Etiquette and Courtesies

Students are not allowed in the classrooms without an instructor present. Please remain in the lobby until the instructor calls the dancers into class.

Parents are not permitted to be in the rooms while class is in session. Please do not disrupt the classroom. If you need to get in touch with your child while they are in class, please address the office.

Star Steppers does not provide child care. It is the responsibility of the parent to pick your child up immediately after class.

Please be mindful of other individuals and classes in session while in the Lobby (i.e. no running/dancing, use inside voices, do not block the doors or walkway).

Water is the only beverage allowed in the studio. **THIS WILL BE STRICTLY ENFORCED.**

No food or gum allowed in the studio. If your child dances more than 3 hours during the day, they are allowed to have a snack.

Star Steppers is not responsible for any items left unattended.

Spring Show

There will be an informal show/demonstration held in May (date/location TBA). We will email more information once it gets closer to the performance date

Photography/Videography

Star Steppers reserves the right to use and photography/videography taken during class, rehearsal, Spring Show, etc. for marketing and advertisement purposes.
