## Pelican Nest Open Soon

Lillian has always been a part of Beverly Tolbert's life. She visited her grandmother Vesta Pound every summer when she was a child. After she got married and realized they would starve to death if she didn't learn to cook, it was "Granny" who came to the rescue, teaching her how to make homemade gravies, cook greens and make gumbo.

After treating friends and family with her cooking talents for many years, she decided to do what everyone had always been telling her, "Open a restaurant."

She kicked around the idea, praying, planning and searching for the right location. She found it in Lillian where "Pelican Nest" restaurant will be located.

Beverly had moved to the area to be near her mom, Yvonne Alder, who lives in Lillian. She and her friend and Rooms To Go coworker Michelle Minor started the search and found a spot in the Lillian Shopping Center. They made a call and were shown the location of a previous restaurant with some of the necessary equipment already available.

They asked their friend Valerie Gore to make a few sketches and "Granny, the Pelican" was born and welcomes visitors at the front of the restaurant. Ironically both Beverly and Michelle called their grandmother, "Granny," so the name stuck.

The new restaurant will be open from 6 a.m. to 2 p.m. Tuesday through Saturday. Breakfast includes eggs, grits, hash browns, biscuits and gravy, bacon, sausage and more. Cost is four items and a beverage for \$7.99, and five items and beverage for \$8.99.

The lunch menu features chicken strips and fried chicken every day, with a variety of specials each day such as meatloaf, spaghetti, ribs, steamed shrimp and roast beef with a variety of side dishes.

The food will be served cafeteria style with meat, two sides, dessert and a drink for \$9.99. On Fridays you may feast on homemade gumbo featuring a generous helping of crab and shrimp for \$8.99.

Hamburgers, crab cake sandwiches, hot dog and chili, and fries are available every day.

"It is so rewarding to see people sitting and enjoying a good meal," Bev said. With the help of her partner, Michelle, mom, brother Robert and

friends and staff, Lillian residents and visitors will have the opportunity to experience that joy.

"There are so many people who don't have time to cook a big meal because they work or have to run to soccer games," Beverly said.

She is thinking about the future. Eventually she would like to provide a take-out service, providing a choice of four meals that would serve four or eight. Patrons would call before 2 p.m. to order and the meal would be available for pick up at a designated time before 6 p.m.

She is also thinking about providing the restaurant for private parties, birthdays, anniversaries and such.

## PBPS Offers Safer Boating Through Education

The Perdido Bay Power Squadron is again offering its Boating Knowledge and Safety Class on Saturday, March 16, from 9 a.m. to 5 p.m. at the Lillian Recreation Park, 33914 Widell Ave.

Certified instructors from the Perdido Bay Power Squadron provide instruction as a courtesy to advance knowledge about recreational boating. The course includes information on getting started, what is needed, required and recommended safety equipment, boating rules to live by, navigation chart overview and related topics.

The cost is \$50 for student

materials and lunch. Please make out your check to Perdido Bay Power Squadron.

Student materials include a student manual, graduation certificate and copies of federal and state rules. Two persons in the same household may share a single book. For those sharing a book, there is an \$8 charge for the additional lunch.

Classes are limited to 16 students. Minimum age is 12, and an adult must accompany anyone under 16. Walk-ins are welcome if space is available.

Successful completion of the course meets the basic boating knowledge

requirements of most states and territories. Education on Alabama boating law is included in the course and comprehension assessed as part of the course final examination.

Reviewing the student manual prior to the class is recommended. Register and buy the student manual at Blue Water Ship's Store, 8103 S. Hwy 59, Foley. 

## Rules of Recycling

Hallelujah! Hurrah! Woo Hoo! After more than a year of being without a recycling location in Lillian, the happy news is, "It's baaaack!"

No, it's not in the park on CR99. The powers that be at the Lillian Volunteer Fire Department have arranged for the bins to be placed at Fire Station #2 on CR91, south of US Highway 98, just south of Maidmont Lane. It's only about four and a half miles from the bridge at Hwy. 98 and CR99, just a seven minute drive, if you obey all the traffic laws.

Now, pay attention. If we want the facility to remain in a convenient location, we have to obey the rules. **NO DUMPING JUNK.** No mattresses, no household garbage, no furniture, no refrigerators, no anything else that isn't recyclable. If you have large items to get rid of, call Baldwin County Solid Waste and arrange for a special pick up. It's free and you can have two bulky pickups per quarter. They will also pick up yard waste, **BUT YOU HAVE TO CALL.**

OK, let's get back to the recycling. At the facility on CR91 you may recycle newspapers and inserts, magazines and catalogs, junk mail and envelopes, cardboard, phone books, office and school papers including colored paper, brown paper grocery bags, boxboard (cereal, cake and cracker boxes, etc.) and plastics #1 through #7.

Also, plastic milk jugs, bottles and containers, aluminum cans and lids, pet food cans and dry pet food bags, aluminum foil baking pans, balls of tin foil and foil pie tins, tin and steel cans and lids, metal pots, pans and cookie sheets.

please break them down so they don't take up so much room. It would also help if you would crush large plastic containers, such as gallon milk jugs.

Now here are the no-no items. **YOU MAY NOT RECYCLE** any glass, plastic bags, ice cream cartons, waxy/paper milk cartons, aerosol cans, juice boxes or bags, household garbage or yard waste, garden hoses, window blinds, tarps, bedding or linens, carpeting or rugs, construction materials, or styrofoam.

Check grocery stores to see if they recycle plastic bags. I know WalMart and Publix do. Publix also takes styrofoam and paper bags. Target recycles glass, plastic, aluminum, MP3s, cellphones and ink cartridges.

A list of acceptable and unacceptable items is available on the Baldwin County web site. We have placed it on Page 23 so take a look. It may be a good idea to clip it out and keep it for reference.

The fire department is going to keep an eye on the bins and will notify the county to replace them when they are full. Since the facility is so close to home, if the bins are full, keep the items in your car and come back another day.

Thanks to the Lillian Volunteer Fire Department for taking on this challenge. Think of all the wonderful things they do for us.

We can at least reciprocate by keeping their property clean and free from junk.


You might be interested (or not) to learn that I now know how to text, email and talk on my new iPhone8. I've also learned my way around the weather app, clock app and meditation timer.

State Representative Steve McMillan addressed the Lillian Civic and Legislative Committee recently. He said the legislature will be focusing on two major state departments this session, the Department of Corrections and the Department of Public Safety.

Rep. McMillan said there are many problems with prisons in the state, including a lack of personnel and mental health issues of prisoners. The state is under a court order to rectify the situation.

He also reported that there are 370 state troopers in the entire state. They hope to hire enough new troopers to bring the number to 650.

Other items on the state's agenda are Medicaid expansion and the possibility of raising the gasoline tax.

Tim Hagle volunteered to be the Lillian representative to the Florida-Alabama Transportation Planning Organization (TPO).

This group is the local governmental transportation policy board for Santa Rosa and Escambia counties in Florida and a part of Baldwin County.

The TPO works to increase safety, security, accessibility, mobility and connectivity for people and goods.

Lillian Volunteer Fire Department member Mark Beyerl

reported the department has purchased a new pumper/tanker at a cost of \$232,000. Other purchases of used equipment are scheduled for the future.

The Lillian Community Club is undergoing renovation of the ventilation system to alleviate problems especially in the lounge area. The cost is \$70,000.

The Lillian Recreational Park has plans to resurface the basketball court and to provide two to three pickleball courts.

Spanish Cove Garden Club members are working from 9 to 11 a.m. on the first and third Tuesdays in the park to spruce up the landscaping with additional plants.

The next meeting of the Lillian Civic and Legislative Committee will be held at 8:30 a.m. Monday, March 11, in the LCC.

The guest speaker will be Robert Munk who will discuss private and municipal sewage spills in Baldwin County. There were 41 in 2018.

Also on the agenda is discussion of strategic growth plans in the county as it applies to proper sewage services.

If you cannot make the ham dinner, membership applications may be picked up at the American Legion building next to the LCC on



## Learning About Microsoft Edge

Edge is the new web browser from Microsoft for Windows 10. It replaced the Internet Explorer web browser that has always been used in all versions of Windows.

Internet Explorer version 11 is the last version created by Microsoft for Windows. Even if it is not visible as an icon on your computer it resides in Program Files on the hard drive.

Edge was developed for Windows 10 to compete and stay as the preferred web browser as technology and web design continues to evolve.

Edge also claims to be faster than any other web browser available. This can be tested readily by running an internet speed test with it.

I used CenturyLink speed test with my DSL connection on Internet Explorer 11, Google Chrome and Edge.

The results were interesting - both download and upload speeds were significantly faster with Edge.


I completed the speed test with Mediacom using same computer and same web browsers with results that internet speeds are faster with Edge.

In most cases you can see the difference when the same web page is loading in different browsers. The browser that loads the same web page faster is the faster browser.

Not only is Edge a faster web browser, it now has the ability for extensions/add-ons.

This update to Edge is primarily for security add-ons/extensions to protect you from erroneous and bad websites.

If you have Norton Antivirus/Security you should be getting a notification that security extensions are available to be installed. If you have not installed them, the next time you get the notification you should do so.



With added security, your browsing the web should be a lot safer.
