ENTRANCE TO THE MEETING

If a member is not willing to show proof or cannot show proof then they can and **will be denied entry**. back to our regular business. We must follow CDC guidelines because of COVID-19 and now the Delta Variant; therefore, we must protect everyone so you are required to wear your face mask at all times. Additionally, seating will be spaced for social distancing purposes.
