Shooters can shoot in which ever match is most convenient for them to attend.

RANGE LOCATION: Smoking Gun Range ,4711 South I-90 Service Rd , Exit 61, Rapid City SD

RULES: Current NRA Pistol Rules Govern.

CHALLENGES: NRA Challenge Rules will apply (Rule 16.1) Fee; **\$3.00**

ARMS ALLOWED: 22 caliber pistol or Revolver (Rule 3.4)

TARGETS: Fifty Foot - **B 2** for slow fire, **B 3** for timed and rapid fire.

ELIGIBILITY: Adult competitors must be a member of their resident state Shooting organization (SD Shooting Sports for residents) Junior competitors may be a member of an affiliated club. Team members must represent the same club, Law Enforcement Group , Military Unit or State Association club (SDSSA). No pick up teams. SDSSA Membership cards will be inspected.

NRA Membership is encouraged but not required.

REGISTRATION FEES: Fee is \$8.00 and each competitor will receive a copy of final bulletin.

ENTRY FEE: \$2.50 per individual match or \$12.50 for Matches 1 through 5
Package entry fee \$12.00 Match 6- \$8.00 per 4 man team

RANGE FEES: \$10.00 payable to RANGE OPERATOR
TOTAL COST \$30.00

ENTRIES: Advance entries are required .Mail registration Cards and Fees to contact to arrive **Seven (7)** days prior to the match date. **12** entries per relay .

CLASSIFICATION: Competitors will be classified according to NRA Classification System in all matches. Be ready to show classification cards and score books on request Unclassified competitors will shoot in the Master Class.

FIRING TIMES: 4 April 2015 at 8 AM **NOTE: You must arrive in time to register and pay fees and be on your firing point by 8 AM ready to shoot. NO EXCEPTIONS...NO EXCUSES**

MATCH SCHEDULE: Match I –20 rds slow fire. Match 2 -30 rds NMC
Match 3- 20 rds timed fire. . Match 4 –20 rds rapid fire
Match 5- SD Individual Championship, Aggregate of Matches 1-4
Match 6 –Team Championship, Team Members Scores of match 2.

AWARDS: 70 % of **entry fees** will be returned to competitors.

Awards for winner of Matches 1 thru 4, winner and class awards provided by sponsor
Class Awards will be given in Matches 1-5:1st – 3 or more, 2nd – 7 or more
3rd-11 or more. The sponsor has the right to combine classes that have less than 5
Entries, no class will be combined with the Master Class. If there a less than 3
Masters entered they will shoot for Match Winner only. Match 6 = 2 or more Teams
Must compete to get awards.

Special Awards: SD Indoor State Champion Plaque will be awarded. (provided by the SDSSA)
SD State Indoor Senior Champion 60+ Plaque will be awarded. (provided by the SDSSA)
SD State Indoor Jr. Champion Award 18yrs & under Plaque will be awarded. (provided by the SDSSA)
If any special award winner is a Non-resident of South Dakota, a suitable award will be provided by the sponsor. The South Dakota State Champion must be a member of SDSSA and a resident of the State of South Dakota.
