Vacation Rentals: A Big Win For Us

As you probably know by now, the Vacation Rental Bill, SB280, was vetoed by Governor DeSantis at the very last minute on Friday, June 27th, at 6:30pm. Whether you're a fan of him or not, he deserves thanks for vetoing this bill that would have destroyed neighborhoods not only in Fort Lauderdale, but throughout the entire state. In his veto letter, he states:

" Under the bill, any such measure must apply to all residential properties. The effect of this provision will prevent virtually all local regulation of vacation rentals even though the vacation rental markets are far from uniform across the various regions of the state."

This veto was due in no small part to all the emails sent by Lauderdale Isles neighbors to the Governor, urging his veto. LICIA received copies of many of those emails, and the neighbors who wrote them were quite descriptive about their experiences with VR's near them. They did not want the City's ordinance to be preempted by the State's very weak proposed regulations. The City has a team of inspectors that work from 5:30pm till 3:00 am Thursday thru Sunday just to handle VR complaints. Their hands would have been tied if SB280 had become law.

We understand that Code Compliance is in the process of continuing to fine-tune the VR ordinance and changes to it will soon be going to the City Commission for approval.

According to the City's website, there are over (1300) licensed vacation rentals in Fort Lauderdale. As you can see in this graphic, we counted (28) legal and illegal VR's in Lauderdale Isles in May. Compare this with May 2021, when we had (7).

Interestingly, the proliferation of VR's may be causing competition between them, and if you scan through the AIRBNB website, you will see VR's with nightly rentals as low as \$250. The AIRBNB owner's not going to get rich with rates like that. Some owners have sold their properties and some have changed them to long term rentals.

As the newsletter was going to press, this issue was developing: neighbors learned that 2507 Nassau Lane has requested a business license from the City to operate a Community Residential Facility for six persons. Incredibly, it appears this may possibly be permitted by City Code / State Statute / Federal Law. Because of the complexity of the legal issues involved, the LICIA Executive Committee referred this to District 4 Commissioner Warren Sturman on Friday, July 26, so that City Management can review the matter and determine what can be done about it.

How well do they follow the new RNAV procedures?

West Flow Departures

If you have been following the Airport Noise Issue, you

know that the FAA has had the Metroplex procedures in effect now for some time. Most would agree that the departing jets stay south of Lauderdale Isles most of the time on their way to the waypoint DREDS, and noise has decreased dramatically for us. However, we all know that occasionally during west winds, there still seem to be a

number of planes that fly over the neighborhood, not to DREDS, for whatever reason. Your LICIA Airport Noise Committee requested that BCAD's consultant, HMMH, provide us information on just how often departing planes fly the desired pattern to DREDS. They developed this graph that shows several different aspects of compliance with RNAV procedures. However, the one we are interested in is the yellow line, which indicates the percentage of westward departures that actually fly to the "initial fix," which is DREDS for us. As you can see, the percentage has improved and since December '23, and it has been between 86 and 92%. Over time we can expect that percentage to improve a little more, and the original goal of consistent 90% or more may very well be attained.

Discover The Birds of Lauderdale Isles

Lauderdale Isles has a unique blend of bird species. South Florida has seen the introduction of nonnative bird species like parakeets and Egyptian

geese. Some of our birds are seasonal, and some are found in our trees, on our power lines, and near our waterways.

Recently my interest in birds has gone from watching from my yard, to actively seeking birds on trails, in parks, and by our waterways and the ocean. I admire and enjoy observing their behavior, but I struggle with identifying species. I went to a birding class at the Bonnet House, where naturalist Paddy Cunningham gave a very thorough presentation about identification of birds. Then she let us in on a secret... there's an app for that.

The Merlin App, by Cornell Labs, uses the same methodology as Paddy, and brings a large database to your cell phone. There is a feature to identify a bird by sound using the microphone on your cell. Another feature identifies birds from your phone's photo library. You don't need to replace your beloved laminated bird guides; Merlin can complement these traditional tools.

Whether you are a casual bird admirer, or a birding aficionado, the Merlin App is a wonderful tool to learn about our neighborhood birds, and it's free.



LIWMD UPDATE

Algal Bloom

Unfortunately, due to the high water temperatures we are experiencing this sum-

mer, the City's Environmental Services Dept. discovered early evidence of an algal bloom at the Lauderdale Isles Landing Boat Ramp on July 23rd. The state Department of Environmental Protection

tested samples and confirmed the presence of blue-green algae.

There are many different types of blue-green algae, some toxic and some non-toxic. The DEP reported that their testing indicated this bloom is non-toxic. However, they recommend avoiding contact with all bluegreen algae and to wash with soap and water if exposed to it. We can expect it in our canals soon. Algal blooms were also discovered in Coontie Hatchie Park, Shady Banks, Tarpon River, and Las Olas & Rio Vista Isles.

Contrary to what you may see posted on Nextdoor by supposed experts, there is no method to eliminate algae in our open water-

ways and we will need to wait until it dissipates naturally when the water temps cool down in October. Please continue to do your part by complying with the summer fertilizer ban and cleaning up after your pets to prevent runoff into the canals. And ask your landscape crew to not blow lawn debris into the water.

Canal Maintenance

The City just renewed the contract with the same canal cleaning contractor, Aquatic Control Group. Their previous contract required them to clean all the canals in the City once a month with their one boat. The new contract specifies the same once a month requirement, but they will be using two boats now. We heard complaints on occasion by neighbors who said the boats cruised down the canals quickly and didn't pick up everything. With two boats, we hope things will improve. They will also be cleaning "hot spots," where debris constantly accumulates in the river & Intracoastal, every two weeks.

Please note: if you observe something in the water that requires their immediate attention, such as floating boards or huge amounts of debris build-up at the north end of the canals, call the City Customer Service number 954-828-8000 and request they come out to take care of it asap, instead of waiting until their next scheduled trip. If you are not satisfied with the service you receive, an email to your District Commissioner works quite well.

Code Compliance on the Water


At a recent LIWMD meeting, Senior Code Officer Marco Aguilera, who handles the Code Compliance Boat, was asked what is the most common water-related complaint they receive. The answer was numerous complaints for over-size boats, throughout the entire City.

Water Testing

The Broward Environmental Lab tests the water at Bradford Marine, across from Andros Lane, quarterly, for e-coli. Their most recent tests, for e-coli, indicate water quality is "good."



- 1. Lawn fertilizers are a big contributor to algae blooms. Leave at least a 10 foot buffer when dispensing fertilizer near a waterway. Fertilizer in the street will wash into the storm drains.
- 2. Never blow or dispose of trash and lawn clippings into our streets, storm drains, or waterways. They are loaded with nutrients and when they decay, they feed the algae blooms. All storm drains lead to the waterways.
- 3. Make sure your landscaping company is not polluting the streets and waterways.
- 4. Report algal blooms to the FDEP by calling 855-305-3903 or by visiting https://floridadep.gov/AlgalBloom.
