An account with invoices past due over 60 days will be placed on COD and a finance charge will apply, for the maximum amount allowed by state law but no less than 18% per year 1.5% per month.

Account privileges are not guaranteed and can be revoked by Direct Truck Shop, Inc. at any time.

COD Customers

A COD account states customer's equipment will not be released until paid in full.

Collections

If the account is turned over for collection you will be responsible for all attorney fees, court costs, and extra costs that Direct Truck Shop, Inc. incurs in order to collect on your account.
