#### **BYLAW NO. 1-2016**

#### A BYLAW TO PROVIDE FOR PUBLIC DISCLOSURE BY MEMBERS OF COUNCIL

WHEREAS it is deemed in the public interest to provide for public disclosure by members of Council;

NOW THEREFORE the Council of the Resort Village of Big Shell, in the Province of Saskatchewan, enacts as follows:

- 1. This Bylaw may be cited as "The Public Disclosure Bylaw."
- 2. Pursuant to Section 142 of *The Municipalities Act*, every member of Council must file a public disclosure statement with the Administrator within thirty days of being elected.
- 3. Every public disclosure statement must be in the form attached to and forming part of this Bylaw.
- 4. Every member of Council who has previously filed a public disclosure statement must annually submit a declaration that either declares that no material change has occurred since the last public disclosure statement was file, or details the material changes that have occurred since the last public disclosure statement was filed.
- 5. The annual declaration as outlined in Section 4 of this Bylaw must be submitted on or before November 30<sup>th</sup> in each year.
- 6. The Administrator shall ensure that each public disclosure statement and each declaration is available for public inspection during normal business hours.
- 7. This Bylaw shall come into force and take effect upon third reading thereof.
