Tent Rental Contract

Making Reservations

Quotes and proposals do not guarantee availability of rental equipment. Equipment will be reserved only upon receipt of a signed rental contract and full payment of rental items.

Cancellations

Reservations cancelled two weeks or before the scheduled date will receive a full refund. Reservations cancelled less than two weeks before the scheduled date will receive a 50% refund of payment received.

Tent Installation

Installation of a tent must be done correctly for the protection of the users, the tent, and ultimately the success of your event. Therefore, it is our strict policy that all installations and takedowns are done by our experienced crews. Holly Tents and Events does its best to protect your property during the delivery, installation and removal process. Client agrees to release Holly Tents and Events of any liability for any damage to any property due to delivery, installation and removal of equipment on your property. This includes but is not limited to ruts in grass, scratches or cracks on surfaces, and high wind related damages.

Site Preparation

Customer agrees, prior to installation of the equipment, to obtain, at Customer's expense, all necessary permits, licenses and other consents. Miss Dig will be contacted and will arrive before the reservation date to mark the necessary areas to avoid during installation. It is the responsibility of the renter to communicate to Holly Tents and Events of any underground wiring, pipes, sewage systems, or anything else that could interfere with the tent stakes. Stakes are driven between 1-3 feet under the ground. If any underground systems are not communicated to Holly Tents and Events personnel or incorrect information is given, Holly Tents and Events will not be responsible for any underground damage.

Delivery & Set Up

Customer agrees to have the site clean and clear of obstacles that prevent access to or installation of the equipment. Installation may take place several days before and/or removal several days after, at the reasonable discretion of Holly Tents and Events. Set up/pick up dates and times will be confirmed at least two days before the reservation date.

Clean up & Preparation for Pickup

All floral arrangements, trash, and decorations of any kind should be removed from the tent or other rental equipment before scheduled pickup time. All tables and chairs need to be wiped clean prior to pick up. The tent must be empty before we can take it down. Please have the area completely clear of any obstructions, besides our rental items, before we arrive.

Missing or Damaged Items

Responsibility of the equipment remains with the client from the time of delivery to the time of pickup. Please be sure all equipment is secured when not in use and protected from weather. Holly Tents and Events will pick up the items on the specified date and time agreed upon prior to delivery. If not all items are present or are damaged, items will be charged to the client at replacement cost. A detailed invoice of these items will be provided to the client.

Weather

Tents are temporary structures designed to handle most normal weather conditions; however, there may be situations that become unsafe such as high winds or lightning. Evacuation of tents is recommended in these or other unsafe conditions. Client understands that it is Client's responsibility to be aware of changing weather conditions and to exercise its best judgment with regard to the evacuation of tents. Client agrees that in the event of a predicted or actual storm or excessive winds, Holly Tents and Events may dismantle any equipment that has been previously installed to ensure safety of all involved. The client is also aware that the tent canvas and vinyl products or the equipment used has been treated for water repellency, but cannot be guaranteed to be waterproof.

Hold Harmless

Customer will take all necessary precautions regarding the items rented, and protect all persons and property from injury or damage. Customer agrees to indemnify, defend and hold harmless Holly Tents and Events from and against any and all liability, claims, judgments, attorneys' fees and costs, of every kind and nature including, but not limited to, injuries or death to persons and damage to property, arising out of the delivery, installation, removal, use, maintenance, instruction, operation, possession, ownership or rental of the items rented.

Authorized Signature

All Collection-fees, attorney fees, court costs, or any expense involved in the collections of rental charges or damaged items will be the client's responsibility. Be sure all equipment is returned according to these terms and conditions. The client is solely responsible for any additional charges incurred as a result of failure to meet these conditions
