The undersigned does release the Club, its directors, officers, and members who may be assisting in any way in said marine events from any and or all liabilities, claims, demands or causes of action what so ever occurring by reason thereof.

The undersigned further agrees that the Club, its directors, its officers, and members shall not be liable for any injury, death, or damage to any person or property caused by or resulting from their acts, omissions, or alleged negligence of anyone else, from weather or lake conditions, hazards of any kind, defects or failure of vessels, or from any acts or omissions or alleged negligence of other marine events, in whole or in part, at the Club.

The undersigned further agrees not to sue the Club, its directors, its officers, its members in respect hereof and, further, to hold harmless to the Club and them from and against any and all liabilities, claims, demands or causes of action against the Club, and them by reason of the acts, omissions, or alleged negligence of the undersigned, any of their crew or assistants, or any 3<sup>rd</sup> party or parties.

This release and wavier of liability shall remain in full force and effect so long as the undersigned shall elect to participate in any of the marine events, in whole or in part, at the Club and the undersigned expressly agrees to assume all acts of risk, in connection therein.
