Minutes of the Regular Monthly Meeting

The meeting was called to order by Don Henning at 7:30 PM.

Also present were Andy Anderson, Jerome Hagenmiller, Connie Marshall, Mary Bettermann and 13 other guest.

Minutes of the last monthly meeting were read and approved

Jerome made motion to except the treasurers report which showed a balance of \$308,197.14 plus a \$200,000.00 CD brings the total up to \$508,197.14 and Andy seconded

Don called for bills to be paid:

Jerome made motion to pay the bills with CK#'s 1359 thru 1369 & Andy seconded. Motion Carried. Connie will read the bills with her treasurers report.

Jim Wittmer asked the board to clean up the road ditch on Sandy Beach Road? The rocks are still in the road ditch.

Charles Bettermann asked if any one checked on spreading the chloride if we have to do it when the county calls and if its raining if we can hire someone else?

Earl Mittag was called upon: Eral stated that the sewer is going down the East side of 64 and wants to get off the sewer list of one of the people getting hooked up. Jerome stated that where ever the sewer is going both sides of the road need to hook up to the sewer. If you live 300 feet off the road you do not have to hook up. Andy stated that we talk about difference situations on a case by case bases. Andy said, he would be ok with them not hooking up to the sewer. Jerome stated that the township can request them to be taken out of the sewer. Mary asked, if the township makes this request to the sewer board, does the sewer board do what the township asks or does the sewer board override the township. Jerome stated he wasn't sure. Don stated, he doesn't have a problem with it, but we could be opening up a new can of worms then. Andy stated, he can't let him by with it, because we would be opening a hole new set of problems. Don stated, leave the way it is. No Action was taken.

Rick Mittag was called upon: Rick asked about weed control. We need to cut the road ditches about two times a season instead on just once. Can we call FSB on CPR acres? Jerome stated yes and if you call us earlier then we can take action.

Clay Hager was called upon: When the road work gets completed he wants the township to take it over. Don said the road work ready by July 1st then Dave Robley will come and tell us to go ahead.

Asphalt will not be put in until the sewer is put in. He is bonding for the Asphalt. It will be 5000 feet not quite a mile. The Association will be responsible for the storm shelter. water pond. That will take place in the next few years.

Charles Bettermann asked we can't take over the road until its completed? It's Bonded it will get completed.
