# A. Consider and Discuss Details for Cisco TX Pie Fest on June 15-16 and Request for Possible Street Closures.

Ms. Jane Nichols presented the Council with details regarding the upcoming event. She further requested a closure of the following streets for the event: Joe Whitely Circle, and the first 100 block of W. 5<sup>th</sup>, E. 7<sup>th</sup> St., and E. 9<sup>th</sup> St. Councilmember Weger asked how the street closures would affect local businesses. Ms. Nichols stated that those businesses affected would be notified ahead of time. The Council agreed that this item should be tabled until those affected businesses could be contacted and agree with street closures.

## F. Consider and Discuss Closing W. 10 Street from Ave. K then 240 Feet West.

Mr. Paul Flores explained that the bridge would be removed and the street permanently closed to improve water flow through the creek in this area. The Council inquired of Mr. Flores as to the disposition of the surrounding property owners. Mr. Flores answered that Mr. Archer could provide further information on this topic.

Motion was made by Councilmember Campbell to table this item until Mr. Archer returns with more information, second was made by Councilmember W. Johnson. Motion prevailed by the following vote:

Councilmember W. Johnson brought up an issue that during ice and snow storms, he feels that city resources should not be sitting on the interstate waiting for wreckers to remove damaged vehicles unless there are injuries or fatalities. Chief McAuley agreed and said it would no longer be an issue.

# I. Announcements from City Council.

Mayor Douglas presented Mr. Butch Petree with a letter from the Mayor in Moran expressing appreciation for his assistance cleaning out a sewer line for the City of Moran.

Councilmember Forester had trees that had fallen during the last weather event and city crews cut and removed the fallen branches. He wanted to voice appreciation for that service.

Councilmember W. Johnson reminded the Council that citizens could dump brush at the Convenience Station free of charge.

Mayor Douglas further articulated thanks to all city employees for work done during the storm.

Motion was made by Councilmember Forester to adjourn, second made by Councilmember W. Johnson. Motion passed unanimously and the meeting adjourned at 6:40 p.m.
