The regular meeting of the Greenbush Township Board was called to order by Supervisor Thelen with the Pledge of Allegiance at 7:00 p.m.

The Agenda was approved by Kindel and seconded by Graham

<u>Sheriff Department Report</u> - Spoke on fraud scams in the area be aware of callers. Also, addressed was identity scams. Department is also closing some old cases by using DNA. Supervisor Thelen brought up he talked to sheriff about people parking vehicle in the clear vision area for sale. Many areas were stated, the sheriff told Supervisor Thelen that the department will start ticketing those who are parked there, they also can be towed, and this is a state law. If there are any stop signs that have any obstructions notify Sheriff Department and they will come and clear it.

<u>CAASA Report</u> - Rescue Operations are going excellent there are two more responders that are joining the crew. There have been 2-4 responders per call with our new rescue unit. They now have telemedicine with CCMC patients and providers.

<u>Road Commission Report</u> -July 19th is expected date for second application of chloride there is going to be 3 stretches of gravel being done in various locations. Motion for Trustee Kyle Graham to obtain contract from Road Commission for skip patching etc. Kindel moved Smith seconded motion passed.

<u>Approval of Minutes</u> – Amendments were made to the name of the business that bid on Fire Hall from Thelen Auto Repair and Collision to K & T Properties – St Johns LLC. Also, it was omitted that there was a vote that there should have been an appraisal done on the Fire Hall Kindel made motion that there was not a need to have an appraisal. <u>Treasurer Report</u> - Was approved with the addition to have Treasurer Pay bills. Also, the budget was approved with amendments. Motion to approve treasures report Kindel moved Graham seconded. Motion to approve the payment of checks 13115 – 13142 moved by Graham seconded by Smith motion passed.
