FIRE DEPARTMENT:

Fire Department reported monthly runs so far have been 17 fire and 34 EMS for a total of 297 runs YTD. Mutual aid was provided to Amanda, Berne, Clearcreek, Pleasant, and Lancaster. A total of 3 runs to SCI. COVID-19 still an ongoing issue. Meeting with Lancaster fire department about the potential decreasing of staff and the increase in runs for them. Engine 651 is out of service. Submitted new list of new officers.

OLD BUSINESS

1. The county will keep Hocking Township informed as to the progress of the OPWC on Meister Road.
2. Hocking Township will continue to monitor Stonewall Cemetery Road and Stepath Mound Lane for erosion.
3. Health Department meeting was the first of March. There is a committee formed to work on some budget issues with them and to plan for the future.

NEW BUSINESS:


