ANNEXATION AGREEMENT

STATE OF TEXAS COUNTY OF FORT BEND

KNOW ALL MEN BY THESE PRESENTS:

THAT, WHEREAS, by that certain instrument designated as Declaration of Covenants, Conditions and Restrictions, dated September 2, 1982, and recorded in the Office of Fort Bend County Clerk, under File No. 39462, Deed Records of Fort Bend County, Texas, those certain tracts and parcels therein described and referred to as:

> All the lots in Barrington Place, Section I, Subdivision, Fort Bend County, Texas, according to the Map or Plat thereof recorded in Volume 129, Page 20, in the Map Records of Fort Bend County, Texas:

MHEREAS, Eldridge Road Joint Venture, a Texas joint venture composed of E. R. LTD., a Texas limited partnership and General Homes Corporation, a Texas corporation, hereinafter referred to as "Declarant" is the owner of a certain property within the area contiguous to the property described as being encumbered in said Declaration of Covenants, Conditions and Restrictions, said certain property being more particularly determined as

> All the lots in Barrington Place, Section IV, Subdivision, Fort Bend County, Texas, according to the Map or Replat thereof recorded on Slides 840A, 840B and 841A, in the Map of Records of Fort Bend County, Texas.

WHEREAS, Eldridge Road Joint Venture, a Texas joint venture, has conveyed, transferred and assigned all of its rights, duting and chligations as Declarant to General Homes Corporation, a Texas corporation, hereinaftur referred to as "Declarant".

NOW, THEREFORE, General Homes Corporation hereby annexes the above described property into the Barrington Place Homeowners' Association and declares that all of this property shall be held, sold and conveyed subject to the Restrictions thereto, all of which are for the purpose of enhancing and protecting the value, desirability and attractiveness of the real property covered thereby. The Restrictions shall be binding upon all parties having or acquiring any right, title or interest in

this property and shall inure to the benefit of each owner thereof.

It is expressly understood and agreed that apparate Restrictions have been filed for record for Bairington Place, section IV, dated Section ber 16 1980 and recorded in the Office of Fort Bend County Clerk under File No. \_\_\_\_\_ Deed Records of Fort Bend County, Texas, which Restrictions, of course, will impress and subject the lots within Barrington Place, Section IV, to an annual maintenance and charge and assessment imposed hereby, and will make such subdivision subject to the jurisdiction of the Association. However, it is understood and agreed that the Association shall (i) enforce the restrictive covenants applicable to Barrington Place, Section IV, and (ii) pay for street lights and for maintenance of entrances to Barrington Place, Section IV (both clauses (i) and (ii) aforesaid to be done in the same manner as the Association does for Barrington Place, Sections I, II and III Subdivisions). It is hereby understood and agreed that the Association shall treat Barrington Place, Section IV () + mondiscriminatory fashion, on an equal basis, and in the same manner as Barrington Place, Soutions I, II and III.
