


A total of 320 man-hours was scheduled; <u>160</u> man-hours were actual dedicated to patrol functions. hours were exhausted on vacation time, workers compensatory, and sick leave. <u>981</u> total miles were driven and the shift responded to <u>523</u> total service calls. The shift issued <u>14</u> traffic warnings, made <u>0</u> arrests and handled <u>10</u> enforcement service-related calls. The average productivity ratio for this month for this shift is <u>3.8</u>


Patrol Activity by Braeburn Valley Personnel:





Security Checks Percentages and Trends







Types of Criminal arrest:






