#### **PURPOSE**

The purpose of the STCA Futurity is to encourage the breeding of the best possible American Staffordshire Terrier, reward diligent breeders for their efforts, recognize the owners for selecting the best quality puppies from responsible breeders, and reward the owners and breeders for raising and developing the inherited qualities of the puppy.

#### SUMMARY

- 1. Nominate litter after breeding but before the puppies are born (\$25.00).
- 2. Breeder of litter must be an STCA member.
- 3. Nominated individual puppies by 4 months of age (\$25.00).
- 4. Nominated puppies compete in the Futurity at Nationals for the year they are eligible as an additional class.
- 5. Both breeders and owners must be members of the STCA for eligibility to compete in the Futurity.

#### **GENERAL**

- A. Correct and timely nominations of both the litter and the individual puppy are required.
- B. Prizes can only be won through competition at the STCA National Futurity held in conjunction with the STCA National Specialty.
- C. Nomination forms are on the website.
- D. Nomination and entry fees cannot be paid by credit card.
- E. The Futurity Director and committee members are eligible to participate in Futurity Competition.

#### I. NOMINATION OF LITTER

- A. Nomination must be made by breeder or co-breeder who must be a STCA member.
- B. Nomination must be made after breeding, but before puppies are whelped. The postmark on the entry envelope is the official date of nomination.
- C. The fee to nominate the litter is \$25.00. There will be no refunds. Late nominations will be accepted up to 30 days after whelping date with an additional fee of \$50.00.
- D. The nomination of a litter makes all puppies in the litter eligible for individual nomination.

#### **II. NOMINATION OF INDIVIDUAL PUPPY**

- A. Nomination must be made by the legal owner or co-owner of the puppy as of the date of nomination.
- B. Nomination must be made on or before four (4) months of age. The postmark on the envelope is the official date of nomination.
- C. The fee is \$25.00 for each puppy nominated. There will be no refunds. Late nominations will be accepted up to 30 days for an additional fee of \$25.00.
- D. An entered litter may be individually nominated by the breeder before puppies are sold by paying the fee for each puppy and supplying whelping date, name, sex and color for each puppy. If neither litter registration number of individual registration number is available at the time of nomination, this must be supplied as soon as available and in no case later than nine weeks before the Futurity judging.
- E. Any changes in the identifying information which will be included in the Catalog must be received by the Futurity Director six (6) weeks prior to Futurity Judging. Failure to provide such information will result in disqualification.

#### III. REQUIREMENTS TO ENTER JUDGING

- A. The puppy must be entered in one of the regular classes, either in conformation or obedience at the STCA National Specialty Show. All entries must be paid in full.
- B. Futurity entry must be indicated as an additional class.
- C. Futurity entry must include age division (e.g., Futurity 6-9, etc.)
- D. Futurity Classes range in age from six months and up. The classes will be 6-9, 9-12, 12-15, and 15 & up.
- E. Puppies are eligible only for the First Futurity Show that is held in conjunction with the STCA Specialty Show held on or after the date the puppy reaches six (6) months of age.
- F. Professional handlers may only show puppies bred and owned by them.

#### IV. CLASS DIVISIONS

- A. There are four age divisions; 6-9, 9-12, 12-15, and 15 & up.
- B. Each age group is then divided by sex.
- C. First through Fourth placements are made in the judging of each class.

#### Classification

10100- Puppy Dogs, 10900- 6 months & under 9 months 10200- Junior Dogs, 11400- 12 months & under 15 months 10100- Puppy Dogs, 11000- 9 months & under 12 months 10200- Junior Dogs, 44400- 15 months & over (Same Classes for Bitches)

#### V. SEQUENCE OF JUDGING

- A. Judging sequence for each age division will be Dogs 6-9, 9-12, 12-15 and 15 & up and then Bitches 6-9, 9-12, 12-15, 15 & up.
- B. Best Dog in Futurity and Best Bitch in Futurity are selected from the winners of the 6-9, 9-12, 12-15, 15 & up classes. After judging of dogs and bitches is complete the Best Dog and Best Bitch in Futurity will enter the ring together for presentation with no further judgement taking place.

#### **VI. TROPHIES AND RIBBONS**

- A. A Ribbon & Medallion will be provided for each placement and a Rosette for Best Dog and Best Bitch in Futurity.
- B. Breed Figure on a Walnut Base will be awarded to the breeder of Best Dog and Best Bitch in Futurity. \$50.00 in Cash will be awarded to the owner of the Best Dog in Futurity and Best Bitch in Futurity.

#### 27000. MATURITY - TUESDAY & THURSDAY

#### I. ELIGIBILITY

Any puppy that was from a nominated litter from the previous years Futurity is eligible to compete in the current years Maturity. (Example: puppy nominated for the 2018 Futurity is eligible to compete in the 2019 Maturity.) The puppy did not have to be shown in the Futurity, it only had to be eligible to compete.

#### **II. CLASS DIVISIONS & PLACEMENTS**

- A. There are only two classes, one for dogs and one for bitches.
- B. Each class will be judged separately.



If you are the owner/exhibitor of a dog registered with a foreign registry (not yet dual registered with AKC) please review the eligibility requirements in The Rules Applying to Dog Shows, chapter 11 section 1. The dog show rules are posted on the AKC Web site at http://images.akc.org/pdf/rulebooks/RREGS3.pdf.

Most important to note are the following:

- Dogs must be individually registered with the American Kennel Club by the day of the event to be eligible for exhibit in the Bred by Exhibitor class.
- 2. Dogs are eligible to compete in AKC events using the foreign registration for a period of 30 days. That 30-day period begins with the date of first exhibit, regardless of whether the dog earned any points or awards. To continue to compete in AKC events beyond the initial 30-day period the dog must be either individually AKC registered or by the date of the event have been granted an extension to exhibit using the foreign registration. The owner or agent can request an extension using the form found on the AKC Web site at http://images.akc.org/pdf/extenap.pdf.

NOTE: MB-F, Inc. accepts entries for AKC events in accordance with the latest Agreement, entry form instructions and Rules Applying to Dog Shows (rules) of the American Kennel Club. From time to time these are subject to change. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- 5. Mixed Breed dogs entering classes for Agility, Obedience, and Rally trials should mark Breed as "All-American Dog/Mixed Breed." Sire and Dam information shall remain blank for mixed breed entrants.
