CONSERVATION STAGE ADJUSTED

While the mountain communities struggled through this winter's storms there is one positive result, replenishment of our water supplies. While Arrowbear Park County Water District is still committed to conserving our precious water resources and to that end the District has a Water Conservation Policy (which can be found at www.arrowbearwater.org) the Board is pleased to be able to move from Stage 2 conservation measures to Stage 1 (more relaxed) measures. The District's policy is in place to protect the health, safety, and welfare of the residents and customers of the District; assure the maximum beneficial use of the water supplies of the District; and ensure sufficient water supplies to meet the basic needs of human consumption, sanitation, and fire protection.

Board Meeting Highlights

Regular Board Meetings are the Third Thursday at 6:30 PM

January – Field Operations Supervisor Weber reported on the maintenance and repairs in the District. Chief Lindley reported on the Fire Department calls for the month. General Manager Huff explained the need to revise the Employee Handbook to comply with new employment laws, reported on the completion of the absorption of CSA-79 (Green Valley Lake sewer) by Running Springs Water District, the successful new hire of Logan Stinson, and RSWD requesting to stop water purchases for now. The Board elected Director Bonito as President and Director Bunyea as Vice President for 2023. The Board also appointed Caroline Rimmer as Secretary, approved the Resolution for Account Signers, discussed the frequency of Regular Board Meetings, had the first reading for the ordinance to adopt the 2022 California Fire Code, authorized Chief Lindley to apply for an AFG grant to replace Engine 271A, and adopted a resolution to acknowledge receipt of a report made by the Fire Chief of the Arrowbear Lake Fire Department regarding compliance with the annual inspection of certain occupancies pursuant to sections 13146.2 and 13146.3 of the California Health and Safety Code. The Board also held the annual Arrowbear Park County Water District Financing Corporation meeting.

February – Field Operations Supervisor Weber reported on the maintenance and repairs in the District and introduced the two new Utility Workers. Chief Lindley reported on the Fire Department calls for the month. General Manager Huff reported on the administrative projects and the FY 21-22 Audit progress. President Bonito made committee assignments for 2023. The Board also had the second reading for and then voted to adopt the ordinance adopting the 2022 California Fire Code, voted to accept the annual Sewer System Master Plan audit performed by GM Huff, voted to amend the Employee Handbook and related policies to comply with new employment laws, approved the District's annual Investment Policy and LAIF Authorization Resolutions, discussed live streaming and remote participation for Board Meetings, and discussed the frequency of Regular Board Meetings with the consensus of the Board being to keep the current frequency, date, and time in place.



March – The Regular Board Meeting for March was cancelled due to the snow accumulation amounts in the District.
