# **Open Burning – Village Ord. 3-2-11**

Burning trash/garbage is prohibited. Burning barrels are no longer allowed within the Village of Pardeeville. Spring burning of dry leaves and other non-offensive dry yard debris is only allowed from April 1<sup>st</sup> through May 31<sup>st</sup>. Burning of damp yard waste and unattended burning is also prohibited and is subject to a citation/forfeiture for violations. Outdoor cooking and campfires are allowed per Village Ordinance in a 3x3 fire pit only. See the Village Code of Ordinances or call the Village Hall if you have any questions.

## **Hydrant Flushing**

The Pardeeville Water Dept. will be flushing water mains during the weeks of May  $14^{\text{th}} - 18^{\text{th}}$  and from October  $1^{\text{st}} - 5^{\text{th}}$ . This flushing will be done during the day from 8:00 AM to 4:00 PM in order to maximize the results of our flushing program. Some discoloration of the water might be noticed. The Utility recommends that residents run water from the cold water tap and flush toilets until the discoloration disappears.

# <u>Election & Voter Registration</u> Mark your calendar to vote at the spring election on April 3<sup>rd</sup>, 2018.

The polls are open from 7:00 AM to 8:00 PM. If you need to vote by absentee ballot or register, you may apply at the Village Office. Future election dates will be August 14 and November 6, 2018.

## License your pet!!

April 1<sup>st</sup> is the deadline to license your dogs and cats. *After April 1<sup>st</sup> there will be a late fee of \$5.00 per animal*. Please remember to bring in proof of rabies vaccination from your veterinarian's office. Please remember...

- Dogs must be leashed or fenced and not allowed to run free and disrupt the public; this includes in your yard!
- Use a "pooper scooper" when walking your dog and clean up after them!

# **Discarded Household Items**

Advanced Disposal will not pick up large items (TVs, refrigerators, freezers, washers, dryers, sofas, chairs, mattresses, etc.) without prior arrangements and a fee. Call Advanced Disposal at 1-920-387-0987. Or you can deliver the items to Columbia County Recycling/Solid Waste Processing Facility at W7465 Hwy 16 in Wyocena for a fee. The phone number is 742-6651. Per Village Ordinances 8-4-8 and 9-3-6 these discarded items <u>CANNOT BE LEFT OUTSIDE!</u> <u>Violations are subject to a citation/forfeiture.</u> Please help to keep Pardeeville neat and clean.

#### **Solicitor's Warning**

Soon solicitors will be knocking at your doors. When they come, ask to see their Seller's Permit. Some groups are not required to have a permit such as the Boys and Girl Scouts, non-profit organizations, permanent merchants, and people selling agricultural products. If any solicitors acts suspicious or in an unprofessional manner, call the Village office and if possible try to get the color, make, and license plate number of the vehicle.

#### **Brush Pick-up**

Brush will be picked up at the curb during the following weeks:

April 9 June 11 Aug. 13 Oct 8

- Pile brush at the curb.
- Small brush must be set out in an open container.
- Trim limbs per the Village Ordinance. Limbs larger than 4" in diameter will not be picked up.
- Brush must be set out at the curb at 7 a.m. on Monday of the scheduled pick-up week.
- Do not set out brush more than 5 days before the scheduled Monday.

# Leaf Disposal

Advanced Disposal will be picking up leaves **ONCE** this spring and **ONCE** this fall. The spring pickup is scheduled the week of May  $7^{\text{th}} - 11^{\text{th}}$  and the fall pickup date is scheduled for November  $5^{\text{th}} - 9^{\text{th}}$ . If you have any questions, please call Advanced Disposal at 920-387-0987. Please follow these simple rules:

1) Leaves must be set out at the curb before 7a.m. Monday of the collection week.

2) Do not set out bags of leaves more than 5 days before the scheduled Monday.

3) Bags should be placed immediately behind the curb of the public street or alley for collection.

4) Leaves must be set out in clear bags only.

5) No garden waste or grass clippings are allowed. Please compost!

Leaves and brush may also be hauled to the Village of Pardeeville property at the Wyocena Town Recycling site on East Bush Road. They are open Wed. from noon to 4:00 p.m. and Sat. from 9:00 am to 3:00

# **Private Wells**

All private wells and sand pints must comply with D.N.R. codes and Village ordinances and are required to have a valid permit. All wells in basements are illegal and must be properly abandoned and inspected by the Village. Failure to comply will result in a citation. Call the Village Hall to renew your Private Well Operation Permit or to get information on a free permit to abandon your illegal basement well.

#### Garbage/Recycling Pick-up

Garbage/Recycling pick-up is every Friday <u>except</u> during holiday weeks where it will be Saturday. Residents must supply their own containers and items <u>MUST</u> be placed to the curb by 6 a.m. to ensure pick-up. Any questions or concerns please contact the office.

## Permits, Ordinances, Setbacks

In the past few years there have been numerous violations concerning the following Village Ordinances:

- Failure to obtain a property building permit
- Violation of property lines and front and rear setbacks
- Parking on unimproved surfaces
- Junk appliances, unlicensed and inoperable vehicles
- Fences

The Village Ordinance Book is posted on our website. When in doubt, call the Village office.

Residents are reminded that permits must be obtained for most property improvements. Contact the Building Inspector, Jim Trebian, General Engineering at 608-697-7779 for an appointment or if you have questions. When planning your construction project, please allow a two-week time frame for appropriate permits, estimates, locates, etc.

## **Pools and Pool Fences**

## **Temporary Signs & Banners**

Please contact the Village office prior to putting up any temporary sign or banner within the Village limits. We will provide you with the policy.

# Regulation of Length of Lawn and GrassesVillage Ord. 6-1-8

Lawns, grasses and noxious weeks on lots or parcels of land which exceed eight (3) inches in length adversely affects the public health and safety of the public in that they tend to emit pollen, and constitute a fire hazard and a safety hazard in that debris can be hidden in the grass. For that reason, any lawn, grass or weed on a parcel of land which exceeds eight (8) inches in length is hereby declared to be a public nuisance. **\*\*In any case where the owner or occupant fails to cut the lawn, grass or weeds, the Village may elect to cut the lawn, grass or weeds and shall charge the expense of doing so to the property owner.**
