MARCH MEETING

There were 23 members present. Mary Ann Music won \$46.00 in the 50/50 raffle. Member Nathan Jolliff would have won \$45.78 if he had been present for the Attendance raffle.

The attendance raffle works like this — when you arrive at a meeting, you sign-in and put 25ϕ into the kitty. You have an attendance number assigned to you based on when you joined the League. After the meeting an attendance number is drawn and if the member is present, they will receive the total amount in the kitty. If not present, it rolls over to the next meeting until someone who is present wins.

RENEWAL DATES FOR CURRENT MEMBERS (NEW RULE)

Please note on 31 August 2017 all memberships will expire as of midnight 31 August of this year and 1 September will be the new renewal date.

Members with expiration dates between January 2017 and June 2017 will pay National Dues of \$10.00 and member Dues will be due on August 31, 2017. Once a member is paid up through 31 August 2017, the Paymaster can submit the member's annual dues any time prior to 31 August 2018. The same will be applicable for all years; the paymaster can have the member pay anytime the paymaster wishes and the dues are extended one additional year to the 31

August date. Only the current fiscal year will be affected by the \$20.00 or \$10.00 National Dues depending on the date of the member's renewal; all other years will be the amount of the annual dues and they are due on 31 August.

Note: All cards will show 1 September as the date (current data base cannot recognize 31 August as the renewal date, it defaults to 1 September.

[A suggestion, going forward, from the National Membership Department is to break the memberships down to certain months and submit transmittals monthly; once the members transmittal is received, they will be assigned the new expiration date of August 31st of 2018] (Remember the card will be dated 1 September).

For new joins, the dates are as follows:

1 Sept – End of February; Cost will be the full annual National Dues plus the National new join fee. (Current cost is \$20.00 + \$5.00 = \$25.00) (The renewal dues will be due by 31 August and the card dated 1 September).

1 March- end of July: Cost is half of the annual National Dues plus the National join fee. (Current cost is \$10.00 + \$5.00 = \$15.00)

The renewal dues will be due by 31 August and the card dated 1 September. New joins during the month of August will pay the full annual National Dues plus the National new join fee (Current cost \$20.00 + \$5.00 = \$25.00) and the card expiration will be 31 August of the following year with a date of 1 September on the card – they will get 13 months of membership for the cost of 12 months.

In his own words, his military history follows:

"I went into the Marines in Aug of 1961 and completed boot camp in Dec '61 at San Diego. Reported to 29 Palms, Calif. for duty. My MOS was Photographer. I worked for the base paper and the MP's doing investigations.

I went for 6 more years in the Corps for Photo School and East Coast duty in 1964. After completing Photo School I received orders for 2nd Marine Div. Camp LeJeune. N.C. While I was there I went on a six month Med Cruise attached to 2/8 Marines aboard the USS Francis Marion APA249. Also went on a 3 month cruise to the Caribbean on the USS Okinawa LPH3.

In 1967 I received orders to a top secret school at a factory in Los Angles for training on a new photo interp. Van going to Viet Nam. Only ten Marines were sent to this school and I was the senior NCO for this new MOS.

Received orders to 1st Marine Air Wing VMCJ-1 Vietnam. Arrived on Dec. 23, 1967 at DaNang. I was in charge of keeping two of the Vans up and running 24 hrs a day. I had a crew of 4 Marines. When not working on the vans I helped keep the photo equipment working on the aircraft and helped on the flight line. In Jan 1969 received orders to Cherry Point N.C.

1971 received orders to 1st MAW Iwakuni Japan. The vans were coming back from Vietnam to Japan and we had to get back up and running. In1972

received orders back to Cherry Point. 1974 Left the Marines and moved back to Michigan with a new baby boy. 1974 went into the Navy Reserves as a 1st class Photographer and retired in 1984.

My Military Schools: ..Photo A School, Photo C School, Photo Interp repair school,, Rocket Launcher and Flame Thrower, Quality Control.

Med Cruise.....Turkey, France, Italy Norway, Corsica, Sardina, England.

Caribbean Cruise....Puerto Rico, Panama, Cuba.

Awards...Navy Achievement with combat "V", Navy Unit Commendation, Navy Meritorious Unit Commendation, Marine Good Conduct, Navy Good Conduct, National Defense, Vietnam Service, Vietnam Cross of Gallantry Unit, RVN Civil action unit, Vietnam Campaign, Navy Pistol and Rifle Expert, Marine Corps Pistol and Rifle Sharpshooter.

AUXILIARY NEWS

It's hard to believe, but spring is here. That also means we're done with our winter "break" and had our first meeting of 2017. I think we all enjoyed seeing each other again and discussing plans for the coming year.

In past Skuttlebutts, we've listed the charities our Auxiliary donated to in the past. Some of these charities we've been donating to for many years and some are more recent. However, there are always

questions about who these groups are and what they do. So I thought it would be helpful to explain this over the coming months and highlight a different group each month. This month's charity is:

Miracle Quilts

Miracle Quilts is a local charity that make quilts for our wounded troops, veterans and veteran families. All of these quilts are handmade. This charity is named after PFC Joseph A. Miracle, A/2-503rd (ABN). PFC Miracle was killed in Afghanistan on July 5, 2007. Founder Carole Carroll and the family of PFC Joseph Miracle wanted to do something in Joseph's memory and started Miracle Quilts. In the month of December alone, Miracle Quilts delivered 30 quilts to Fisher House, Landsthul, Germany, 21 to Troy Beaumont Hospital (veteran patients), 52 to North



Oakland County Friends of Veterans Court (children of the veterans), 42 to WWII Pearl Harbor Ceremony in Lake Orion, MI., 2 to local veteran families which included 8 children Christmas quilts and pillowcases and to 1 local veteran suffering from a stroke. Our donation was used to purchase supplies for these wonderful quilts which I believe are truly "Miracle" quilts. Our Auxiliary president, Loretta Balderson brought this charity to our attention. Knowing this about Miracle Quilts and information about the other charities on our donation list, helps us with our decision to support them.

For our April meeting, we'll be looking at different plans for raising funds this year. Bring a friend if you'd like. We're always looking for new ideas <u>and</u> new members. See you on April 6th.

DJD YOU KNOW

ARTICLE NINE - DUTIES OF OFFICERS

SECTION 1 - Commandant

It shall be the duty of the Commandant to preside at all meetings, to call special meetings, to appoint Committee Chairman, to supervise, direct and control all activities of the Detachment in such a manner that will bring credit upon the Marine Corps League. This is an elected position. 1. The Commandant may appoint the following officers prior to the Detachment Installation: Service Officer, Liaison, Historian, Quartermaster, Deputy Quartermaster and any other office the Commandant may deem necessary for the proper function of the Detachment.

SECTION 2 - Senior Vice Commandant

It shall be the duty of the Senior Vice Commandant to preside at meetings in the absence of the Commandant. When the Commandant desires to make an announcement from the floor, he will relinquish the chair to the Senior Vice Commandant, who shall preside during such period. When the Senior Vice Commandant is presiding, he shall have all the power and authority of the Commandant. The Senior Vice Commandant shall be responsible for the Chairman of the Membership Committee of the Detachment and shall have the power to call upon any Detachment member to assist him in his recruiting work. This is an elected position.

HISTORIAN'S CORNER

MARINES OF OUR PAST

Medal of Honor Recipient Private Samuel Gross, USMC

CITATION

In company with members of the 5th, 13th, 23d Companies and the Marine and sailor detachment from the U.S.S. Connecticut, Gross participated in the attack on Fort Riviere, Haiti, 17 November 1915. Following a concentrated drive, several different detachments of marines gradually closed in on the old French bastion fort in an effort to cut off all avenues of retreat for the Caco bandits. Approaching a breach in the wall which was the only entrance to the fort, Gross was the second man to pass through the breach in the face of constant fire from the Cacos and, thereafter, for a 10-minute period, engaged the enemy in desperate hand-to-hand combat until the bastion was captured and Caco resistance neutralized.
