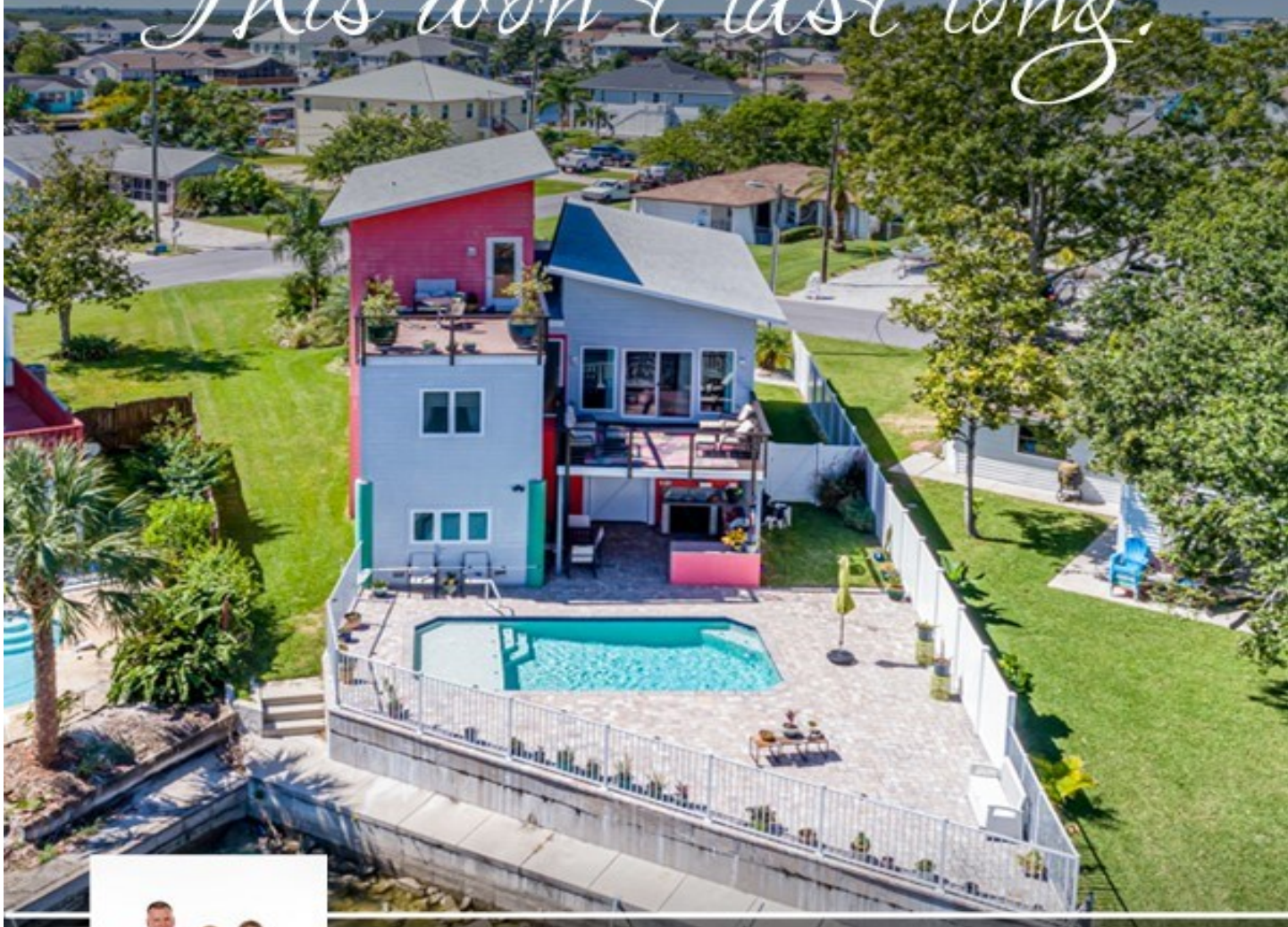

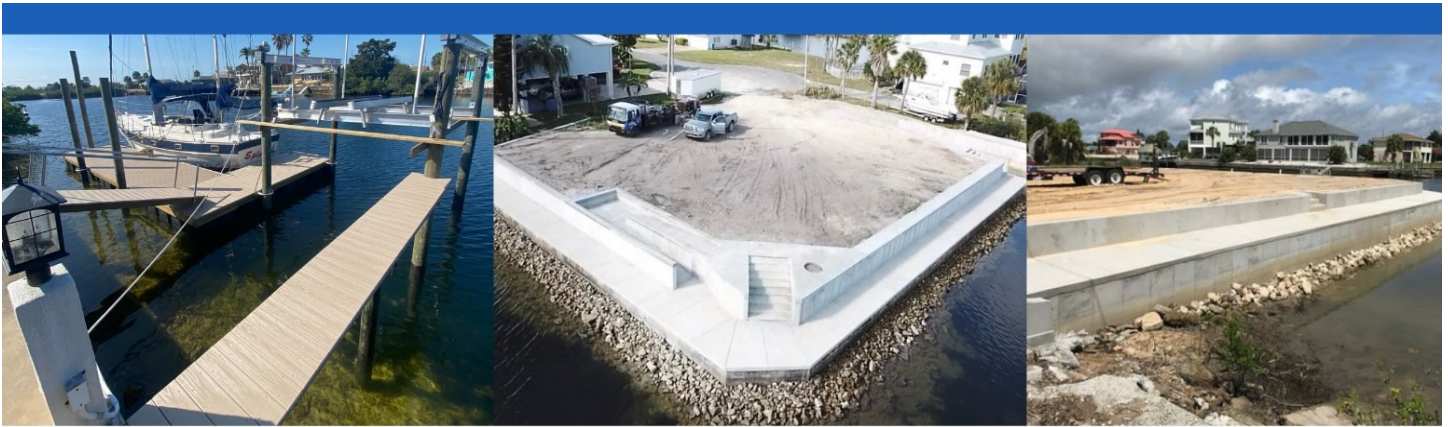
## ROTARY CLUB FUNDRAISER

A lively discussion occurred at the 20 Oct 21 Hernando County Waterways Advisory Committee (WAC) Board meeting. The principal area of discussion revolved around what constitutes a "marginal dock", how large in square feet can it be, and how far can it extend into the rivers, and coastal canal systems in Hernando County. be no lower quality than hot dip galvanized.

(2) All bolt heads and nuts shall have a flat washer. Use of lag or anchor bolts must comply with the manufacturers' specifications. Carriage bolts are permitted for minor additions (such as ladders).

(3) All wooden members and pilings shall be pressure treated with a minimum treatment of 2.5.

(4) Ramp to dock hinges shall be no less than one-fourth-inch steel.

(5) All floating docks must have a minimum of twenty (20) pounds per square foot flotation.

(6) All ramps must be connected to the seawall with no less than three-eighths-inch by three-inch lag bolts with lead shields per hinge.

(7) All floating docks with single ramps must be safely secured to the seawall from each inside corner of dock with no less than one-fourth-inch steel cable.

(8) All ramps will be a minimum width of thirty-six (36) inches.

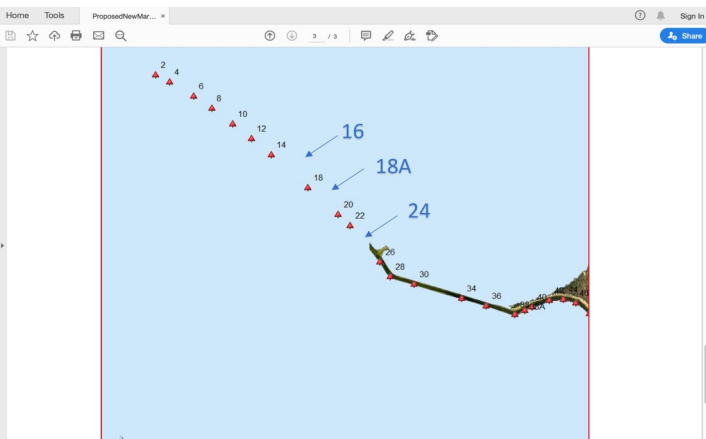

### CHANNEL MARKERS

Additional Entrance Channel Markers, Hernando Beach Inlet. At the 20 Oct 21 Waterways Citizens Advisory (WAC) Board meeting there was discussion about channel markers and the frequency at which they are having to be replaced. According to our Waterways and Aquatics Manager, routinely 2-5 piles/markers are damaged monthly by vessels transiting the Hernando Beach Inlet. In order to increase safety and boater awareness, the consensus recommendation of the WAC was to add three additional channel markers to include chained floating buoys to better define the channel boundaries and to improve boater safety. Attached is a graphic of existing red and green channel markers and where the additional three markers are proposed to be placed.

Hernando Beach Crime Watch (HBCW) meets from 6:00 to 7:30 pm on the 2nd Wednesday of the month at the VFW Post 9236 at 3435 Shoal Line Blvd. (next door to the H.B. Fire Department). Crime Watch is a non-profit 501C3 volunteer organization that functions under the Sheriff's Department. We have a patrol car driven by members who have been certified thru an application with the Sheriff. We drive the neighborhood of Hernando Beach and report any suspicious activity directly to the Sheriff's dispatch for further investigation.

Our meetings are open to the general public. At meetings, we discuss safety issues, have speakers of special interest to Hernando Beach, a land Deputy or water Deputy discusses statistics in our area plus addresses concerns, and answers questions. There is a social time after our meetings with a 50/50 drawing and home-made treats by Nancy Wach or Public's bakery.

receive counseling through the outreach offices based in Hernando County, to receive safe shelter women and children had to be transported to Marion County, a round trip distance of 110 miles. The primary focus of the agency was and continues to be the provision of quality services to victims of domestic and sexual violence and their children.

Before long it became apparent that the transportation of women and children out of county was not adequate to address the growing needs and numbers of women and children in crisis in Hernando County. Isolating women and children from extended-family members, friends, employment, familiar surroundings including school, and friends etc. was emotionally harmful.

By July of 1993, a group of concerned citizens spearheaded by then State Senator Ginny Brown-Waite launched a local campaign and raised \$95,000 which allowed for the purchase of a large, four floor, single family home in Hernando County, to be brought up to fire code to house 24 women and children, and become Hernando County's only safe house for victims of domestic violence and their children. Dawn Center of Hernando County became an independent corporation in July 1993 and was determined to be a private, not for profit agency.

The first women and children to be offered safe shelter at the Dawn Center house was in the early Spring of 1994, giving the opportunity to provide counseling, support groups, children's programs, and life and parenting skills in a caring, supportive environment, while being able to give

relevant, Hernando County referrals to assist women in their plans for housing, employment and education.

In 2004, Dawn Center received funds to build an addition onto the shelter of four additional bedrooms, two bathrooms and a family room. This addition allowed for the shelter of up to 40 women and children. Dawn Center was also able to enlarge the kitchen area and purchase new appliances. In 2005, Dawn Center received Capitol Improvement money through the Department of Children and Families to improve the security system with new cameras, privacy fencing, and security gates to provide better surveillance of the property thus enabling Dawn Center to provide a much safer and more secure environment for residents of the emergency shelter program.

The center has consistently grown resulting in Dawn Center staff providing services to more than 1,400 survivors of domestic and sexual violence annually. The center currently offers an array of intervention services such as hotline, emergency shelter, outreach services, and legal advocacy. The addition of primary prevention services is reaching out to the next generation to facilitate social change in hopes their generation will be free of family violence and sexual assault. Operating under our current mission statement, "To break the cycle of domestic and sexual violence by providing supportive services and leadership that promotes social change," Dawn Center is ever working to achieve our vision of "A community free from violence and abuse."

### OCTOBER FISHING REPORT

Inshore fishing is very good right now and will stay this way for the next few months. Red fish are schooled up in large groups 12-40 in a school on the outer islands and mangrove points. Snook are mixed in the same areas as well and snook are holding on the rock bars. Spotted sea trout are working back into the shallow waters (2-5 feet) on spotty bottom and hard lime rock bottoms. Use live bait for reds. Snook and trout are producing the best action; my go to bait is live pilchards.

Gag grouper are biting good in the 7-16 feet depths, around rock piles, ledges and reefs. Live pin fish and pilchards will get the grouper happy and eating well. Mangrove snappers are all over the rocks in the same depths; small baits or cut bait rigged with a 1/0 circle hook and a light leader 20lb is all you need.

## WEEKI WACHEE RIVER



The **Weeki Wachee River** is in Hernando County, Florida, United States. It flows 7.4 miles (11.9 km) westwards from Weeki Wachee to the Gulf of Mexico at the Weeki Wachee estuary. The name is derived from the Seminole: *uekiwv /oykéywa*, wi:-/ "spring" and *-uce /-oci/* "small", signifying either a small spring or an offshoot of a town named Spring. The spring's average discharge is 112 million gallons a day. The sandy-bottomed spring pool is large, at 165 feet by 210 feet, but the vent is a small 20-foot by 3-foot opening through exposed

limestone rock at a depth of 185 feet. The force of the discharge is too great for safe entry except during drought conditions. Divers report that the cave has a room like tunnel that is 55 feet wide, 28 feet high, and 220 feet long. They have been able to map and explore over 6,700 feet of deep passages, and report 1 pit to be just over 400 feet deep, the deepest recorded in the United States. The river is best known for its spring, and the Weeki Wachee Springs attraction built on the premises. The spring is the surfacing point of an underground river, which is the deepest naturally occurring spring in the United States. The water temperature is a steady 74.2 °F (23.4 °C) year-round. The Weeki Wachee springshed, which contributes groundwater to Weeki Wachee Springs, is approximately 260 square miles of urbanized areas, agricultural lands and forested uplands. This springshed covers portions of Hernando and Pasco counties. Weeki Wachee Springs is unique in that its largest spring vent has an extensive underwater cave system that has been explored to a depth of more than 400 feet. In addition, there is a long historical record of water quality and discharge data dating back to the 1930s. It was also designated a Surface Water Improvement and Management priority water body.

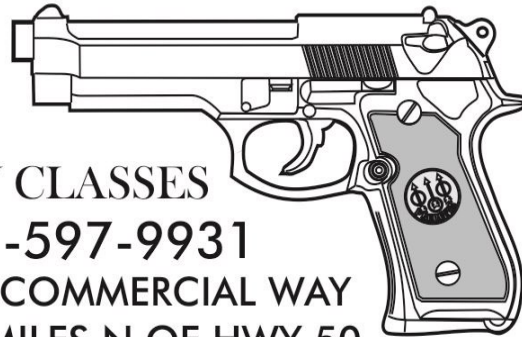

## ADOPT-A-ROAD



The Adopt-A-Road program allows citizens to show pride and maintain a clean, attractive community. Your business or community group can help keep roads litter-free by adopting an approved one-mile section of county-maintained roadway. Each group signs an agreement to clean up litter at least four times a year. The Department of Public Works provides safety training, two Adopt-A-Road signs, "litter crew on road" signs, safety vests and trash bags.

Adopt-A-Road signs are placed at each end of the selected roadway, give recognition to the group and remind people not to litter. If desired, the program offers an installation ceremony and publicity at the time the signs are installed. When the cleanup is completed, the group notifies the De-
