Dear Calvert Main Street Business/Building Owner,

The Hunters Moon Main Street Moon•Fest, **“TOP HATS, ANTLERS & TIARAS”** Wine, Ale & Spirit Stroll will be held on Saturday, October 19, 2019 from 4pm to 7pm. The purpose of this event is to increase awareness and revitalize Calvert’s historic business district on Main Street. All Main Street businesses and building owners are invited to participate as a **Featured Wine/Beer Destination Stop** to showcase your business and historic building. *To be a designated wine/beer stop for the event, the participating fee is \$100.* This fee will cover the cost for promotion, wine stop signage in front of your store during the event, temporary event TABC permit and wine or beer to be served at your location. Your business will be included in all the wine, ale & spirit stroll promotions including website and social media and featured on the Event Map. A winery or brewery will be partnered with your business and an actual representative *may or may not* be at your business site to pour (1 oz. wine or a 2 oz. beer tastings) to participants. Wine/Beer Stroll ticket holders will receive a commemorative event wine glass (**sponsored by Robertson County Veterinary Services**) and wine glass lanyard (sponsored by **Eagles Fly Drone Imagery LLC**) at check-in 30 minutes before the event.

- Each participating business will be expected to provide 2 staff members or volunteers to serve as a greeter for their business and assist with pouring during the event. A designated area in your business will be required to set up a table (or large counter space) for the event wine/beer to be displayed and serve from during the event.
- Each participating location will be required to complete a Participating Wine, Ale & Spirit Stroll form, Business Authorization letter and if applicable, a Landlord Authorizaion Letter.
- We have a limited number of stops, all applications will be processed on a first come, first served basis, but every effort will be made to include every business and building owner who wants to participate.
