The approval of the tentative budget is an agenda item later in the meeting. If approved, it will be posted and published. The hearing for the budget will be held at the July trustee meeting.

ASSISTANT CHIEF CAMPBELL'S REPORT

The final agreement with Pierce has been worked through and agreed to in concept. Ken Lenz made a motion, seconded by Craig Warning, to have Pierce repair the corrosion on Truck 92's torque box and frame rails at a cost of \$73,000.00. Motion passed with a roll call vote as follows: Ken Blank aye, Ken Lenz aye, Craig Warning aye, William Haas aye. The truck will have a pre-inspection done upon arrival at Pierce; everything working at that time will be checked on the post inspection, and if not working at that time, will be repaired by Pierce at no additional cost.

Oak Forest Fire Department has approached MFPD to assist them in creating a preventative maintenance program and having their preventative maintenance performed by the MFPD fleet maintenance division. There was no objection from the Trustees on this.

The scissor lifts at each station have proven to be useful not only by our personnel but by various vendors as well. By owning these lifts, we save approximately \$300 per station, per vendor, per visit.

Twin Supplies has completed the update on the LED light fixtures at each station. Once Com-Ed completes their post inspection, the grant paperwork will be completed.

The Board reviewed the POC ride-along report for the month of April.

ASSISTANT CHIEF CIRELLI'S REPORT

Laraway Dispatch has begun utilizing the automated Dispatch (digital voice). There are some pronunciation issues that are being worked out. They are still addressing staffing and training issues. This will be a long-term project. We actively participate in the operations committee as well as the training committee.

A/C Cirelli attended a meeting in Homer Glen on May 2 where public safety and public education was discussed. They will put our public education events on their website..
