As we have seen recently, the Club may not always be able to meet face-to-face, which necessitated a change to the Bylaws, specifically Article 5.2. The change allows postage to be minimized, and also allows the Club to lessen the annual expenses of the Nominations and Elections process. The changes being discussed will allow the Board to retain full oversight and complete transparency to the members. The Board believes the changes will help streamline the nomination and balloting process when appropriate, benefiting the Club and the volunteers who serve. Club members will be receiving a ballot and also a letter which contains an explanation of the changes being considered. Please return your vote to the return address listed on the mailing that you will receive.

The Club welcomes two past members, Denny and Shirley Lind, as well as a new member, Kevin Johanson. Welcome to all of you.

The Board also discussed the need for Tune-up Clinic volunteers to assist with various vehicle projects requested by members. Please contact Dave Peterson or Dale Pomerleau via email or phone, to tell them what project/work you would like completed at the Tune-up Clinic, and/or to volunteer to help work on member's vehicles. The Tune-up Clinic needs volunteers to work on projects. Updated information about the May 15 Tune-up Clinic, hosted by the Halter's is within this edition of the Aogah News.

The use of a SCRIP card is a potential fundraising tool for the Club. Volunteers have stepped forward to help with a trial period. The Club will determine if we move forward after evaluating the trial period.

LAST MONTH MINUTES: The March 9, 2021 Board Meeting minutes were reviewed and approved, motion by Dave Peterson and seconded by Catherine Jammer, motion carried.

The Board, and members, discussed a proposal created by Catherine Jammer and many others. A proposed change to Article 5.2 regarding the nomination process was put forth. Peter motions that receipts from Doug be submitted to the board, to cover the technology costs for roster/membership expenses. Catherine seconds the vote. The Motion was carried by unanimous vote.



As caretaker of this 1930 Ford Model A Coupe that was bequeathed to me by my late father, a mechanic by trade, who was always found in the shop helping someone with some aspect of their car, whether it was an oil change, tire change, engine rebuild, body work, and sometimes it was helping a good friend complete a restoration vision for the vehicle. When he was not in the shop, he could be found either at a car parts swap meet or a car show. He loved the Ford Model A, its design and simplicity, and purchased this vehicle with fond memories of simpler times, and a vision to restore the vehicle to its original glory.

My father was unable to complete the restoration that had begun, and it was my pleasure to complete the restoration in his honor. My journey to restore the vehicle began the first night my foot stepped into the Twin Cities Model A Ford Club clinic. There, I was warmly welcomed, and began to learn how the simplicity of the car systems worked together. Many club members offered their assistance with the project in their respective areas of expertise. Not only did they bring their experience, they brought their enthusiasm and willingness to teach. They embodied and demonstrated the true purpose of the club, and I am thankful for their commitment and dedication to this project, as they were very aware of what the project meant to me, and they honored that. It was a pleasure to have worked and learned from so many wonderful people.

The opportunity to learn from and enjoy the camaraderie and friendships that have been made through this project soon found myself paying it forward by supporting the club as President in 2019 & 2020, organizing and leading a National Collector Car Appreciation Day Car Cruise in support of the Model A Youth Restoration Award in its passion to help youth restoring Model As, passing on the knowledge taught to me by helping others with their visions for their Model As, but most of all driving and enjoying the living piece of history that my father loved.
