# Trash and Waste Pickup

The regular days for trash pickup in Country Village are Monday and Thursdays. We have contracted with VF Waste and have door to door service. Please see the criteria below for additional waste/trash that is not put into a trash can.


Additional waste will be picked up provided it meets the following requirements:

- Waste must be properly "bagged, boxed or bundled" so that a worker can lift them.
- The weight must not exceed 65 lbs. per bag, box or bundle.
- Place items 3 feet from your container so our workers can collect them.
- The dimensions cannot exceed 2 feet by 2 feet by 3 feet.

If disposing of large items such as appliances or furniture, call us at 713-787-9790 so we can dispatch the appropriate vehicle to your location.

# TREASURER'S NOTE

The good news is that year-to-date we have collected approximately 96% of all 2014 annual dues. The bad news is it's not at 100% which is what we strive for (roughly 22 homes for about \$18K is still due). Expenses have remained consistent over the last two years as Security, Trash Removal and the Pool continue to make up a majority of expenses. Fortunately we have had no surprises with exception of some small unforeseen expense items associated with pool repair. This has allowed the Board to allocate operating cash to our reserve account which, by year end, we estimate will be at approximately \$225K. We're getting stronger and will be in much better position to plan for repair/replace necessary communal items when things happen.



#### **DEED RESTRICTIONS/VIOLATIONS – CALL TO VOTE**

We live in a fast pace and changing market as we have seen an increase in property values and home sales in Country Village. As a result, we've seen an increase in homes going through a myriad of changes from small "face lifts" to full internal and external renovations. The Board and our homeowners are starting to witness a number of deed violations and have had several residents seeking remedy. The Board has a responsibility and an obligation to develop a better process of monitoring and enforcing the deed restrictions from the way they're currently outlined. We feel that once we complete the task of preparing new amendments, sharing them with our community, seeking approval of proposed amended changes to DCCR's/deed restrictions that we'll start to see less violations and have the ability to enforce violation issues more timely and with greater impact.

Unfortunately, the current covenants restrict the Board from fully enforcing deed restriction violations, which has frustrated many residents, and can ultimately lead to negatively impacting home values. Therefore, at this year's CV Annual Meeting the Board intends to introduce a set of amendments to our community that will allow the Board to better enforce deed restriction violations going forward. We need the help and support of our homeowners to review these amendments, ask questions, seek clarification and ultimately vote to support the changes. The desired goal is to preserve our community and homeowner values and drive accountability for residents to remedy any violations sooner rather than later.

Proposed amendments will be available on the CV website for review as well and will also be mailed to each homeowner in advance of the annual meeting to allow ample time for review. Please feel free to submit any questions to Board members directly or through the CV website.
