ANNOUNCEMENT TO THE CONGREGATION OF COMMUNITY PRESBYTERIAN CHURCH

Last summer when we reopened our sanctuary, your Session agreed to follow the COVID-19 protocol of the ND Smart Restart Risk Levels. To the people of Community Presbyterian Church, who belong to God the Father and the Lord Jesus Christ: May grace and peace

be yours (Good News Translation 1:1b)

Here I am writing for our November newsletter! The first day of November is when Daylight Savings Time ends. And the last day of November is the 1st Sunday of Advent. Time moves on.

We do not need to anticipate our first snow; we are already experiencing snow enough to shovel! The pumpkins on our steps are covered with snow! We live in a state with four noticeable seasons. Sometimes we love it, and at other times we are just not ready to let go, preferring to hold on to the season rather than moving on. Our tendency to "hold on" to what we are (Continued on page 2)

comfortable with applies to more than just seasons. As humans, we get in a place where we feel secure and want to stay. It is hard sometimes for us to let go of our sense of security and venture out into the unknown.

Whether we are resisting the change in

the patterns of our life, many of us are struggling with the impact of Covid-19. Some are going through the actual experience of being quarantined. Sometimes we end up there because we had been close to someone who had been diagnosed

with Covid-19 and we are patiently (or not so patiently) awaiting results ourselves. Even within our own church family, the reality of Covid-19 has hit closer to home than we wanted. It is hard to ignore Covid-19 when we experience it within our own family and friends.

I have been praying and hoping this would all be over, so it did not interfere with our upcoming Thanksgiving, Advent, and Christmas plans. You may have been experiencing that desire to do what we have always done and not have to change. It reminds me of how many of us felt when we realized that we would be having Palm Sunday and Easter via online worship. It was not the same as we were used to. We learned to have Virtual Communion. We learned to praise God online. We learned that the sky did not fall if we did not sing, but spoke our hymn text.

All had been going along as we began worship in the sanctuary again. Then the numbers started rising. Cass County is now High Risk. It is scary. Some would prefer we just keep doing what we had been doing because we really do not want to change again. Others understand that it is more complicated than we like to admit. We moved back to online worship only again beginning with our October 18 worship. How long will it

be before we can worship together in our sanctuary? I do not know. No one knows, which makes this so difficult. It is about change, about the unknown and we are simply not so good at dealing with leaving our comfort zone.

What we do know is Jesus loves us whether we are worshiping online or in

the sanctuary. God hears our laments. Our monthly women's Bible study has been focused on laments. I wrote this lament the day before we learned Cass County was in the High-Risk category. I encourage you to write your own lament.

Gracious and loving God, creator of all. Life is more difficult than we want; we are experiencing great times of grief and fear and anger. Dear Lord give us the tools to work through this chaos, we know you hear our pleas. We trust you are with us, giving us strength and courage while you guide us through these times. In the name of your Son Jesus, we pray for your mercy and grace. Amen.

CPC BUILDING IMPROVEMENTS

Community Presbyterian Church has had quite a year, along with our community. Since March we

have experienced the new world with coronavirus. It impacted our church community as well as others. The road back has been hindered with living in a county with continued positive cases, children on different schedules, people being cautious, as they should be, when the potential hazards are formidable. CPC was back to holding worship services in the sanctuary and providing Sunday School for adults and children. Now we are worshiping online again. Even though some things are staying open, we know that we will not have everything back exactly the way it was. Yet, even though things may be different, we trust our Lord and Savior to guide us as we go forward.

We are excited to tell you that we have good news!! Community Presbyterian Church is in the middle of major upgrades as part of the response to the global pandemic. How? You may be asking! Let's take a look at how the process has unfolded. Back in August, North Dakota announced that money from the Cares Act was to be distributed through the state in the form of grants known as Economic Resiliency Grants (ERGs). Stewardship Committee identified this as an exciting opportunity to enhance the safety of the church facilities as it relates to the Covid-19 coronavirus and other viruses such as seasonal flu. With the integral help of the Trustees, Community Presbyterian Church was well-positioned in our grant submission.

The grant submission covered three major upgrades 1) HVAC upgrade to install I Wave Commercial bi-polar ionization air cleaners 2) Electrostatic Foggers (equivalent to the technology used in the schools and colleges), and 3) replacement of water facilities to include touchless faucets and touchless bathroom fixture upgrades. The current status of the upgrades is: HVAC project is complete; the Electrostatic Foggers have been ordered, and a bid

from a plumber has been received on the water fixture replacement.

On September 30th, 2020, Community Presbyterian was informed that we would receive the ERG grant in full and that our upgrades would be of no cost except for the sales tax. ERG grants do not cover sales tax. The news that we qualified was greeted with great joy by Session. This is a significant step in providing a safer worship environment.


