2. Naturally skip hire involves heavy haulage. Therefore, we cannot give you a cast iron guarantee of a precise time for delivery or collection of your skip. Our drivers may be delayed on another job, held up in traffic etc. We will do our best to accommodate your requirements and get in touch if there are issues.
3. Our vehicles require plenty of room to access/ egress your property safely. Please bear this in mind when making your booking. If you have any queries about access, please include this on the application form.
4. J Sanders and Son will not accept responsibility for damage of any kind because of a skip or Ro-Ro bin being moved from its original position. Bins MUST NOT be moved from there original position under any circumstances.
5. Our drivers will only place a bin on hard standing, although this may not always be the most convenient for loading, it is the safest way of delivery.
6. Skips/ Bins will not be placed on a public highway, access road or public foot or cycle path without the relevant permit being produced by the Customer.
7. On no account should a fire be started in your skip. Damage caused to a skip by fire or otherwise will be charged for on a 'replace for new' basis.
8. Members of the public including the Customer/ Producer are to stand a minimum of 3 meters away from the vehicle when loading or unloading. We will not accept responsibility for injury incurred during this process providing we acted with reasonable care and skill.
9. You MUST NOT overload your skip under any circumstances as it is illegal. This can cause problems with picking up the full skip and cause unnecessary danger to pedestrians and motorists alike. The metal must not be placed higher than the top of the skip. For Health and Safety reasons, J Sanders and Son always reserve the right to level off the top of the skip, to make it safe for transportation. If this is necessary, we may need to charge you for another skip/ bin.
10. Access to where the bin/ skip is to be delivered/ collected must be free from obstruction i.e., trees, low wires etc. If the Customer/ Producer orders the vehicle to enter the property, they do so entirely at their own risk against the advice of JSS representatives. Providing we act with reasonable care and skill and are not negligent we will not accept liability for loss or damage suffered by the customer.
11. Pavements, driveways, and manhole covers etc., may not be constructed to carry the weight of a heavy vehicle. In the event of the Customer/ Producer ordering the vehicle off the public highway against our advice, they accept full responsibility for any damage which maybe caused. Providing we act with reasonable care and skill and are not negligent we will not accept liability for loss or damage suffered by the customer.
