Ordinance O-2019-23

**AN ORDINANCE AUTHORIZING THE MAYOR
TO PURCHASE 72" BOBCAT AND ANCILLARY ITEMS**

WHEREAS, the Village participated in the procedure carried out by the State of Ohio Procurement Office whereby contracts for purchase of supplies and services are awarded on behalf of political subdivisions and other entities pursuant to R.C. 125.05(B)(2); and

WHEREAS, the Village sought necessary equipment pursuant to that procedure as part of Ohio State STS515W, #80704; and

WHEREAS, as part of that procedure the Mayor has obtained an quote, attached hereto ("Quote") for the purchase of a Bobcat 72" Sweeper and ancillary items for the amount of \$6,975.60; and

WHEREAS, Amelia Village Council finds and determines that the attached Quote provides an acceptable cost for the described equipment, which is needed to carry out its municipal duties; and

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that;

SECTION I. Council hereby authorizes the Mayor to purchase the Bobcat as described on the attached Quote, for the amount of \$ 6,795.60.

SECTION II. Council hereby finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.
