South Sound USBC CLASSIC MASTERS USBC Certified - Scholarship Tournament

Tournament Rules

- 1. This tournament is open to all USBC Youth bowlers. USBC membership cards must be presented at checkin. Entrants will use highest **current** USBC certified league average based on a minimum of 18 games as of February 1, 2017. If a bowler has a certified (sanctioned) sports league average, rule 202d in the USBC Playing Rules book must be observed. It is the bowler's responsibility to use the USBC rule book conversion chart to adjust his/her average. Rule 319a2 10-pin rule will not apply. **Attach current standing sheet**. If no current average, use 2015-16 book average.
- 2. This event will be a **SCRATCH** competition in four average classifications, which will be combined boys and girls.
- 3. Entry fee will be \$25.00 per entry: \$13 lineage/expenses & \$12.00 prize fund. Prize fund will be paid out 100% in plaques and scholarships (administered by the SMART program Acct. #9009).
- 4. Entries must be postmarked no later than **February 22, 2017** or hand carried and received at the South Sound USBC office no later than 5:00 p.m. on **February 24, 2017**. <u>You must submit your average verification as of February 1, 2017 with entry.</u> Late entries will be considered up to 9 a.m. on February 19, 2017.
- 5. The qualifying round will be held on **Sunday, February 26, 2017 at 10:00 a.m.** Each bowler will bowl four (4) games of qualifying to determine the finalists in each division. The top five (5) finishers in each division will then advance to the stepladder championship round to be held 30 minutes after the qualifying round. In this round the 5th qualifier will bowl the 4th qualifier, and then the winner bowls against the 3rd qualifier, winner bowls against 2nd qualifier, and then the winner bowls the top qualifier for the Classic Masters Division Championship.
- 6. **First place winners will receive their awards at the SSUSBC Annual Awards Banquet.** Plaques will be given to the winners. All other awards will be presented within 30 days of tournament completion. Perpetual trophy will be displayed at the bowling center of the highest placing SSUSBC bowler. Awards will be presented on a 1:5 ratio in all divisions with prize fund returned 100%. Any added scholarship money will be pro-rated per division.
- 7. Dress attire must be neat, clean and proper fitting. Collared shirts or USBC or South Sound official youth jersey and slacks, Bermuda shorts, capris, skirts or skorts must be worn. Skirts and skorts must be to the end of fingers when arms held down to side. Tournament Director must approve any/all exceptions. Tournament Director's decision is final. No jeans, sweatpants, leggings, or other casual wear permitted.
- 8. Misconduct/Poor Sportsmanship on or off the lanes during the tournament competition will NOT be tolerated. This can result in disqualification from the tournament and forfeiture of entry fee, position and any scholarship prize. The rule will be enforced at the discretion of the tournament director and committee.
- 9. If there is an error in scoring, contact tournament director or front desk immediately. All other conflicts with the general playing rules must be made to the tournament director no later than 30 minutes after completion of the tournament. The director will decide questionable errors. Any protests must be confirmed in writing to the South Sound USBC Association within 72 hours. Each protest under this rule must be specific in itself.
