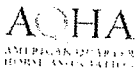

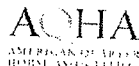

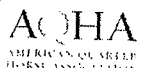

Once the judge has marked this card, there shall be no changing of placing except for clerical errors. If clerical errors are made, they must be initialed by the judge. The judge must place all placings for 1-9 entries, 9 for 9-34 entries, 10 for 35-39 entries, 11 for 40-44 entries and 12 for 45 and over entries. Place to 15 in all Leveled classes that are run concurrently. (ie: if Rookie and Level 1 Horsemanship run concurrently, place 15 entries.)
