## *From your Town Supervisor*

Greetings Wilmington Citizens. Here's the news out of the Supervisor's office.

I ask the Town to welcome Nicole Forbes as the new Clerk to the Supervisor. A Wilmington native, daughter of Steve and Nancy Randall, granddaughter of Ellen Paret, Nicole comes with a strong financial background and will be a perfect fit for the Town as we say goodbye to our clerk of more than thirty years, Shirley Lawrence. Shirley will be training Nicole until June 30<sup>th</sup> when she retires. So please welcome Nicole and thank Shirley for her many dedicated years of service to our community.

### **Water Meters**

Beginning in February, your water usage will be billed according to the new metering system. Billing will be twice a year in February and August. There is a new base rate and then a sliding scale based on usage. Most people will see a drop as our new base rate for a residential home will be \$ 70.00 for up to 20,000 gallons bi-annually, with a 10% discount for seniors. The new commercial rate is \$ 140.00 bi-annually up to 40,000 gallons. Contact the Water Superintendent or the Town Office with questions. There is not a more fair way of billing than paying for what you use. I will caution that if you are a large user of water your bill could rise significantly.

### **Dredging**

After many, many years the Dredging Feasibility Study is complete. The bottom line cost estimate, without permitting, is 2.5 million dollars. In the future, I would like to see an informational vote to see if taxpayers are willing to foot the bill for this, as it would be a significant

tax increase. We would lay out what the increase would be over a 30-year period to allow the public to make an informed decision whether to move forward or not. I would not anticipate much, if any, grant funding as dredging is not seen as being environmentally friendly. A copy of the study is on file at the Town Offices.

### **Grant News**

The Town has been awarded a \$200,000 Micro-Enterprise Grant from the NYS Office of Community Renewal. This grant is for low to moderate-income businesses, which through an application process, can apply for funding for start-up or for an existing business. Several applications have been received and awards are anticipated to be made by March 1<sup>st</sup>.

The Town, in cooperation with ORDA, Essex County Planning, and Adirondack Architectural Heritage



has secured a \$250,000 grant for repairs to the buildings and stonework on the summit of Whiteface Mountain. Our most important treasure, the Whiteface Mountain Veterans Memorial Highway has been falling into disrepair. This committee was formed by the Town to search out funding for the repairs to the Highway itself and the infrastructure. This step is just the first in a very long process in securing funding to revitalize this national treasure. We are currently awaiting the results of an engineering study being performed by NYS

Department of Transportation for repairs to the road itself. We wish to thank the local DOT personally for their assistance in getting this study performed.

### **Town Beach**

The new bathrooms are 90% complete with the finishing touches to be done in the spring. Work is 50% complete on the new boat launch, and the new cedar log lighting is being constructed by our highway forces during down time this winter. The pavilion construction is scheduled to be started in the fall.

### **Youth Center**

Buy the time you receive this we should have a new Youth Center Director on board. We thank Michelle Hozley for her years of service. We plan to revamp the structure of the entire program and have a grand re-opening celebration.

The Town Board and the Youth Commission are meeting together to brainstorm new ideas. We are going to try a split time for different age groups, with Saturday from 12-4 being for just 12-year-olds and under. Thanks to Ted Holzer for being a great interim director! Stay tuned for more information as time goes on.

### **Trails**

We have been working closely with DEC forester Rob Daley on our local trails. The Wilmington Wild Forest plan was enacted in 2005 with very little money to complete the plan. Aside from our wonderful Flume Trails, a snowmobile/mountain bike trail was approved.

The snowmobile trail would run from the North Pole 100 Acre Woods up the mountain to the Cooper Kiln Trail and then over the backside of the mountain to tie in with the Franklin/Clinton County trail systems.

The mountain bike part would run from the North Pole 100 Acre Woods to the Cooper Kiln Pond and tie in with the trail to the flume system. When this is finished it will be an immediate economic boom for the Town.

Next we would be looking to tie the Flume and the Hardy Road mountain bike trails together, continuing to make Wilmington a fantastic mountain bike destination. This project is a priority for us, and we are hopeful we can have a finished product soon. Thanks to Jim and Mary

I hope everyone is having a safe and healthy start to 2011.

I have some encouraging news about our Verizon cell tower. Verizon Wireless has included the construction of our tower in their 2011 budget. I did not get any timetable from them yet, but I will update everyone at the Town Board meetings as I hear from them. If it takes the rest of this year for the construction and start up of the tower, that's only five years since I first approached them on this project. How time flies when you're trying to accomplish something so beneficial to the welfare of the community.

The process of upgrading the Town's Zoning Code is finally approaching its completion. There will be a final public hearing at the March Town Board meeting. It was a long process and the committee is very thankful for all the input and cooperation we received from the citizens and business owners in our community.

## ***How Is Our Library Funded?***

When you ask this question, the common response is “through our tax dollars.” This is true, but only to a limited extent.

The library compiles the budget each year based on trends from the prior year. The 2011 budget is a balanced budget and the total budget is \$29,000. There are three sources of funds that the library depends on:

- AuSable Valley School District contributes \$3500
- Lake Placid School District contributes \$11,000
- Town of Wilmington contributes \$9,000
- Total contributions are \$23,500

These amounts leave a shortfall of \$5,500. Where does that money come from? Primarily, the shortfall is made up from small grants, fundraisers and donations. Despite efforts to raise additional funds in 2010, the library ended with almost a \$1000 deficit.



What does the library spend money on beside books? The library pays for fuel oil, electricity and water. We pay for the telephone; however, our internet service is donated. We have four public use computers--all maintenance of the computers is donated; however, the printer and copier use paper and toner cartridges, which are purchased. The Library Director is paid a salary. In addition to the salary and associated taxes, the library must pay disability, workers' comp. and liability insurance. These categories comprise the bulk of the expenses.

The library has received several endowments with the stipulation that only interest income is to be used. With interest rates so low, the income from these endowments is nil.

The Friends of the Library are an independent group which raises money to assist the library. The Friends hold fundraisers twice a year and conduct a giving campaign in March. The Friends assist with book purchases, however, their primary focus is the maintenance of the library. In the past, they purchased replacement, energy-efficient, windows and front door, the ramp to the building, the security system, and numerous other enhancements. They also pay for the library to be cleaned on a weekly basis. This year, the library building is facing major maintenance issues. Windowsills are rotting, the building exterior is deteriorating and the stone pillars need to be redone. This maintenance work cannot be put off any longer and will be the focus of the Friends' fundraising activities. The Town maintains the insurance on the building, removes snow and trash, mows the lawn, and does what it can to assist in maintaining the building.

How can you help? The library greatly appreciates donations to underwrite expenses. For example, Eye Care for the Adirondacks donated funds toward the purchase of large print books. Also, a fund has been established in the memory of William Carr and historical books are purchased with those funds. In 2009, a loyal patron underwrote the cost of fuel oil. Additionally, supporting The Friends of the Library in their fundraising endeavors is most welcome. As expenses continue to grow and income stays relatively the same, it is up to us as a community to assure the library thrives and is able to provide the services our citizens deserve.

***Paid Emergency Medical Technicians***

The Wilmington Fire District Commissioners and the Wilmington Town Council have joined together to make Wilmington a safer place to live and work. There is a growing problem throughout the country that has finally reached our community. It is getting harder and harder to get and retain volunteers for emergency medical response. The training requirements are very long and the hours these volunteers give to the community add up fast. At an emergency meeting of the Commissioners, Fire and Rescue officers, Town Highway Superintendent, and the Town Supervisor, a plan was devised to help keep our community safe.

The Fire District had already hired Jodie Agee, who is certified in Critical Care, to work one day a week to respond to ambulance calls, do all the necessary mandated paperwork and keep the ambulances fully supplied. With the new agreement, Christopher Hozley, an EMT and lieutenant of the Rescue Squad, has been hired to work for the Town's Highway Department and will also work with both the Water and Parks Department as needed. He will work four, ten-hour days per week and will automatically respond to any ambulance calls during those hours. His salary will be paid half by the Town, which already has that money in the budget for part-time workers, and half by the Fire District, which will draw the money from funds collected by third party billing of ambulance calls to Whiteface Ski Center. Also, Miranda Ward, who is certified in Advanced Life Support, will be hired per diem by the Fire District, to work if either Jodie or Christopher needs time off.

With this plan in place, there will always be an EMT to respond to ambulance calls, Monday through Friday from 6:30 am till 5pm. After 5pm, and on the weekends, our volunteer EMT's should be home from work and be able to respond to calls. It is a win-win situation for Wilmington residents.

***FEMA Grant***

The district is once again fortunate to receive a FEMA grant for \$30,000 to purchase new Turnout Gear and new Water Rescue Suits. The district thanks Randy Preston for his diligence in filing these grant requests

***New Roof***

The flat roof on the firehouse has been leaking and has had numerous repairs. The district will have the roof replaced this spring when the weather breaks.



### Program News

On September 11<sup>th</sup>, 2010 the Wilmington Historical Society sponsored a booth at Wilmington's Festival of Colors entitled "Wilmington History on September 11<sup>th</sup>". We presented a display of photos, documents and stories of important past events which occurred on the date September 11<sup>th</sup> that affected Wilmington/

Jay residents (Wilmington was a part of Jay until 1821).

The first major event was the September 11<sup>th</sup>, 1814 Battle at Plattsburgh during the War of 1812 in which our United States was, for a second time, defending its sovereignty against Great Britain. Many Wilmington/Jay residents of the time took part in the battle. Among those featured in the display were Major Reuben Sanford, who is often touted as a hero in the Battle of Plattsburgh; Corporal Stephen Partridge, who died in a skirmish with the British a few days prior to the Battle of Plattsburgh; and Private Asa Lawrence, an ancestor of many of the Wilmington/Jay area Lawrence families.

Many similarities can be found between the Battle at Plattsburgh and the more recent 9/11 attacks in 2001, both occurring, for example, on the same day of the year and at the same time of day. Also featured, with a direct tie-in to Wilmington, was a 9/11 story and photos contributed by recent Wilmington resident Steve Peters, who is a direct descendent of the same Pvt. Asa Lawrence of the 1814 Battle at Plattsburgh. Steve's story recalls his experience in the aftermath of 9/11 by serving in credentialing for security at the Emergency Operations Center (through ORDA) in New York City in the week following the Trade Center attacks.

Yet another major event was part of the display-- September 11<sup>th</sup>, 1929, when New York Governor Franklin D. Roosevelt was in Wilmington, accompanied by many other dignitaries, to turn over the first shovelful of dirt to commence the construction of the Whiteface Mountain Veterans Memorial Highway. Other "September 11<sup>th</sup> in Wilmington" documents and happenings were presented in our exhibit as well, including some September 11<sup>th</sup> weather in various years.

In addition to the static exhibit, the Wilmington Historical Society began collecting other 9/11 stories from Wilmington residents for the WHS archives, either verbal or written, so that future generations can better understand our connection to the events of 9/11/2001. The WHS continues to collect Wilmington residents' 9/11/2001 stories. If you would like to add to our collection, you may write your responses to the following two questions and mail to Wilmington Historical Society, PO Box 174, Wilmington, NY 12997.

- 1) Where were you/what were you doing when you first heard about the 9/11 attacks?
  - 2) How did the events of 9/11 affect you and your family both short term and long term?
- In return you will receive a Deed of Gift which allows the WHS to own the material and gives the donor a receipt.

In a separate booth at the Festival of Colors, Sid Ward presented his locally famous cutting boards for sale, all proceeds to benefit the Wilmington Historical Society. Many thanks, Sid!

## ***Dog Owner Information***

As of January 1<sup>st</sup> the State required that the Town take over all aspects of dog licensing. All dogs over four months of age are still required to be licensed. Dogs will be issued new tags at the time of licensing or renewal. You will receive a "Friendly Reminder" from the town when licenses are due. All licenses are required to be renewed each year. Licensing requires that rabies vaccines be up to date. There is a new dog control law that is available by contacting the Town Offices or may be viewed on the town website at [townofwilmington.org](http://townofwilmington.org).

Please be a responsible dog owner and **vaccinate and license your pet**. Not licensing your dog could result in a court appearance. Having your pet identified with a dog license or rabies tag is also useful in finding the owner when a pet becomes lost. Licenses may be obtained at the Town Clerk's Office at the Community Center. **All dogs are required to be under control of the owner on a leash at all times**. For the protection of wildlife NYSDEC will issue violations for dogs running loose. Thank you for using the new receptacles for dog waste clean up, located at the beach and on Route 86.
