Minutes of October 7, 2016

The Huntington Township Trustees met in regular scheduled session at 7:00 PM at the Township Hall. The meeting was called to order with the pledge of Allegiance by Robert Holmes. Also present were: Walter Rollin, Jed Lamb, Dennis Finkel, Sheila Lanning, Dimitri Szynal, Janet Hollingsworth.

Motion by Rollin with a second by Lamb to approve the minutes of the September 17, 2016 regular scheduled meeting. Roll call: 3 yeas. Warrants (7575-7600) and charges totaling \$24,234.36 were examined and approved for payment. *Motion* by Rollin with a second by Lamb to approve the August financial reports showing year to date revenue of \$397,368.16 and year to date expenditures of \$263,798.48, with bank balance of \$333,959.59. Roll call: 3 yeas.

COMMUNICATIONS: NEXUS pipe line meeting October 19th Elyria High School.

Holmes reported: Janet Hollingsworth in attendance to speak about the Herrick Memorial Library 1.25 mil levy on the November ballot. The levy is a .77 renewal and .48 additional. Hollingsworth stated the cost to a \$100,000 home is \$38.45 a year. *Motion* by Holmes with a second by Rollin to authorize *Resolution 2016-48* supporting the 1.25 mill renewal and addition levy on the November ballot. Roll call: 3 yeas. Thanks to Finkel and Szynal for getting walking trail in shape for Fitness Walk today. Jerry Inness has Bergman OPWC file folder and sent a letter to Bergman to complete project. Discussion on drains allowable to be run to ditches. Advanced road closure SR 83 between SR 82 and Grafton Eastern Rd (10-7 to 10-21). SR 58 closed south of SR 162 for railroad track repairs. Lorain County Sheriff did building check on 26th of September. RLCWA hydrant maintenance reports received.

Rollin reported: October 5th is Fire District Chili cook-off at the Eagles. Banquet for safety forces coming up.

Lamb reported: Rural water board can't decide on what page to start the review of policy on. Rural Water Board and LORCO Board meetings are this week.

Fiscal Officer reported: Auditor of State Hinkle training October 12th. Audit release notification received. Need to amend appropriations: *Motion* by Lamb with a second by Rollin to approve *Resolution 2016-47* to amend appropriations to pay tax collection fees. Roll call: 3 yeas.

Road Foreman reported: Hawley Road ditch cleaning hopefully will be completed by winter. There are 257,000 miles on the Kenworth, it is using or leaking oil, will get pricing for repair.
