Reports: Fiscal Officers Report -

Mr. Weidner referred Council to the March 2016 Bank Reconciliation, Cash Fund Reports, and payment register. The reconciliation report shows the Village books reconciled with the bank. The Village has a pooled cash balance of \$3,187,410.38. Since it was the end of the quarter, council was also provided copies of the appropriation and revenue status reports. *Mr. Dave Wallace moved to approve the Fiscal Officers Report as submitted. Ms. Joan Maxwell seconded the motion.*

Board of Public Affairs -

Mr. Greg Iiams and Ms. Pat Cochenour updated council on the progress of the iron filter repairs.

Street Department –

Mr. Tim Reese reported that the department is preparing for a couple of paving projects on SR 708 and SR 366. They will also be repairing potholes on Robin Alley.

Parks & Recreation -

The wood mulch has been removed from the municipal building playground. The replacement rubber mulch has been delivered and paid for through the Mary Rutan Foundation Grant. The purchase of a shelter house to be placed at the municipal building has been approved for purchase using the remaining funds from the grant. Replacement materials will be quoted to repair fencing at Leppich ball fields.

Police Report -

Chief Freyhof reported on the recent GovDeals auction where three forfeited impounds were sold and noted that there are other items that are being gathered for the next auction. He will provide council with a list of items being sold, however council stated that they do not need to approve the list prior to being sold. A finance meeting has been scheduled for Thursday, April 21st to discuss the direction of the police department after the recent failure of the police levy. Chief also noted that Rite Aid is preparing to have a Wellness Fair & Bike Rodeo in cooperation with the police department. They asked if it would be possible to have the event in the Municipal Building parking lot.

Ms. Joan Maxwell moved to allow the use of the Municipal Building parking lot for the event. Mr. Dave Wallace seconded the motion.

The program will allow Mr. Hall to act as Clergy for bereavement and death notifications. The solicitor will prepare an ordinance to establish the program.

Zika Virus -

Mr. Jim Biery would like to use the building to hold a meeting on Thursday, May 12th at 9:00 a.m. to discuss the Zika Virus and how to prevent harboring of the mosquitos.

OLD BUSINESS:

A. Storm Water Construction Phase I (CDBG Grant)

Mayor Reames updated council as to the progress of the construction. Though Beaverdam Construction had less than 48 hours of down time while waiting on utility lines to be moved, the company has demobilized and moved to another job. They are supposed to return in May to complete the project.

B. New CDBG Grant Applications

The village will be applying for two CDBG grants. One to remodel the main entrance of the Municipal Building to become ADA compliant, and the other will be to install drainage tile and pour concrete pads for a shelter house and a half-court basketball area in the Municipal Building park.

C. <u>Verizon Tower – Property Repairs</u>

Two quotes were received, one for repairing the property to the prior condition (\$2,790) and one for installing a gravel parking lot in lieu of grass (\$15,791). The Mayor would like to submit a bill to Verizon for the \$2,790 and use the money to help pay for the installation of a gravel parking lot. Mr. Mike Hennon of Verizon will be asked to attend a future council meeting to discuss this option further.

NEW BUSINESS:

A. Stokes Township Variance Meeting

Date Passed

Stokes Township will be having a variance meeting to hear a case involving the construction of a hotel on Tecumseh Island. Due to the nature of the variance, they are expecting a large turnout to the meeting. Mayor Reames noted that the township may be asking to use the municipal building to hold the meeting which is scheduled for Monday, May 9th at 7:00.

Ms. Joan Maxwell made a motion to adjourn the meeting and seconded by Mr. Dave Wallace. The meeting was adjourned at 8:19 p.m.
