AMELIA VILLAGE, OHIO ORDINANCE O-2018-43

AN ORDINANCE CONFIRMING THE MAYOR'S APPOINTMENT OF JOHN HYDER AS FULL-TIME ADMINISTRATIVE COORDINATIOR FOR AMELIA VILLAGE AND DECLARING AN EMERGENCY

WHEREAS, Amelia Village needs a full time Administrative Coordinator; and

WHEREAS, based on the recommendation of the Mayor, Council desires to appoint John Hyder as the full time Administrative Coordinator for Amelia Village.

NOW, THEREFORE, be it ordained by the Council of Amelia Village, Clermont County, Ohio, that:

SECTION I. Council of Amelia Village ("Village Council") does hereby confirm the Mayor's appointment of John Hyder to work as the full time Administrative Coordinator for Amelia Village beginning January 1, 2019.

SECTION II. John Hyder has served a probationary period of one year as part time Administrative Coordinator and the Mayor, with the concurrence of Village Council, appoints him to serve as full time Administrative Coordinator for Amelia Village.

SECTION III. Mr. Hyder's annual salary shall be \$26,900.00 beginning the first pay period of 2019, and paid out once a month with Council and the Mayor's pay.

SECTION IV. Village Council hereby finds and determines that all formal actions relative to the passage of this Ordinance were taken in an open meeting of this council, and that all deliberations of the Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION V. This Ordinance is hereby declared an emergency which is necessary for the preservation of the public health, safety, and general welfare. The reason for such necessity is that the full time position of Administrative Coordinator will be vacant at the first of the year. This appointment will allow the Village to provide necessary uninterrupted administrative services to the citizens of the Village. Therefore, provided this emergency clause receives the affirmative vote of two-thirds of all members elected to Council, this ordinance shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise from and after the earliest period allowed by law.
