

CERTIFICATE OF AMENDMENT TO THE DECLARATION OF PROTECTIVE COVENANTS CONDITIONS AND RESTRICTIONS FOR COUNTRY MEADOWS

The undersigned officers of Country Meadows of Sarasota Homeowners' Association, Inc., a not for profit Florida corporation organized and existing to operate and govern Country Meadows, according to the Declaration of Protective Covenants Conditions and Restrictions for Country Meadows thereof as recorded in the public records of Sarasota County, Florida in O.R. Book 3065, Page 2558, et seq., and all amendments thereto, hereby certifies that the following amendment to the Declaration was duly adopted in the manner provided in the governing documents of the Association and applicable law, including an affirmative vote of at least two-thirds of the voting interests of the Association, at a duly convened meeting on September 25, 2020.

(Additions indicated by underlining, deletions by strikethrough)

1. Amendment to Article XVII of the Declaration of Condominium to read as follows:

Article XVII RENTAL OF PROPERTIES

- Section 1. The rental of any property within Country Meadows Involving new occupants shall be for a minimum of one (I) year (12 months). Length of renewals to the lease holders of the previous year (12 months) are at the discretion of the lesser and lessee.
- <u>Section 2.</u> At no time shall the number of rentals exceed 15% or 20 of the 125 homes in the Country Meadows Community. All rental properties must register with the Association by February 15th of each year or be fined for non-compliance. New tenants must file an application form found on the Association's website. The form then must be submitted to the Association Board of Directors for approval before moving into the property.
- Section 3. No Owner shall enter into any agreement for the rental of any Lot, Parcel or portion of any Lot or Parcel, or any structure thereon, until the 548thth day following the date that the Owner becomes legal title holder to any Lot or Parcel.
