AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS FOR EMERALD POINTE SUBDIVISION

THIS AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS FOR EMERALD POINTE SUBDIVISION made this 20 day of 4, 2006, by the EMERALD POINTE HOMEOWNERS' ASSOCIATION, INC. (hereinafter referred to as the "Association");

WHEREAS, Emerald Pointe Subdivision is subject to the Declaration of Covenants, Conditions & Restrictions for Emerald Pointe Subdivision recorded in Book 7564, Page 0830, Wake County Registry (hereinafter referred to as "Declaration"); and

WHEREAS, the Board of Directors of the Association (hereinafter referred to as the "Board"), on behalf of the Association, desires to amend the Declaration in order to correct provisions within the Declaration relating to vehicle parking; and

WHEREAS, the Declaration provides in Article X, Section 1, the Declaration may be amended by a two-thirds (2/3) vote of the Association's Board; and

NOW, THEREFORE, the Association hereby declares that the Declaration shall be amended as follows:

- 1. The Declaration shall be amended to include the following provision as Article VIII, Section 15:
  - 15. No boats, trailers, campers, motor homes, trucks, tractors, dump trucks, tractor trailers, or other shall be parked on any Lot, on the Properties, Permanent common open space, Consolidated Open Space Development, Open Space or on any right of way of any roads or streets within the Properties, or on any private or public streets within Emerald Pointe Subdivision by any Owner or its respective family, tenants, invitees, agents, subcontractors, or employees, except inside an enclosed

garage located on a Lot or in a specified storage area established by the Association.

2. Except as set forth herein, the Declaration shall remain in full force and effect.
