-Sandberg informed the board that there were a couple water shut off's in the last week due to non-payment.

SEWER

-The new pump at the North Lift Station went down - will be pulled and cleaned out to see if that will clear up the problem. This pump is 2 weeks old and could possibly be defective. Will inform the board when the decide what has happened to it. Information was given to the board about a pump with slicers to cut up the debris that is being thrown down the sewer system. These pumps are 7-1/2HP with a cost of \$5450 plus approximately \$100 to upgrade the circuit breaker. The cost to purchase the same pumps (5HP) that are currently installed would be \$3300/each and have no slicers.

After some discussion, Wegrzyn made a motion to purchase 2 - 7 1/2HP pumps with slicers @ the cost of \$5450/each. Haar seconded, motion carried.

The Village will also have 2 - 5HP pumps for back up to be used at either lift station.

NEW BUSINESS

- -One Paw'z will be sponsoring a car show in September and has requested a Main street closure. The board will allow, but feels the county must be contacted concerning this closure.

- -Discussed the Extended warranty for the generator at the South Lift Station. Haar made a motion to purchase the 10 yr. extended warranty for a total cost of \$975. Wegrzyn seconded, motion carried.
- -AAA Tree Service will remove the tree in front of Judy Terando on March 10. While he is in the village, he will look at the tree in the alley behind B. Hansen's home and send an estimate for removal.
