YOUR SERVICE OFFICER SPEAKS By Leo D'A. Balbach

GOVERNMENT INSURANCE... A veteran who desires to convert his National Service Life Insurance policy from a TERM plan to a PERMANENT Plan is reminded that the conversion is merely from one type to another type of Government policy. No commercial company is involved in a conversion of a Government policy as has been intimated by certain commercial insurance salesmen. Therefore, it is suggested that if you desire to convert your TERM policy to a PERMANENT policy that you contact me to effect such conversion, or for that matter, any other question regarding your Government insurance ... If you hold a participating TERM policy you should investigate the advantage of changing such a policy to a PERMANENT Plan. The premium rate for TERM insurance is based upon the individual's age and becomes larger with each renewal when the term period expires. The average World War II veteran is nearly 40 years of age. As a consequence many veterans would benefit financially by converting to a PERMANENT type of policy as under the PERMANENT type of policy the premium rate at your age at time of conversion will thereafter remain the same. EDUCATION Veterans who are at least 21 years of age and residents of New York State are eligible to take tests to earn NYS High School Equivalency Diplomas. The five tests in the series include exams in Social Studies, Correctness and Efficiency of Expression, Science, Literature and General Mathematics. The tests are held several times a year. Applications and dates of tests in this area may be obtained from Curtis High School.... A veteran is eligible to complete a USAFI correspondence course after discharge from active service if he is enrolled in such course while in active duty. Nine months is permitted from date of discharge to complete the USAFI course....

THE GI BILL PROVIDES THAT AN APPLICANT FOR TRAINING WILL BE DISAPPROVED if the applicant is already qualified for the job he proposed to learn in the course of training. He will be considered a qualified worker if at any time in the past he has been employed as a full-fledged workman in the trade for which he requests training. He will also be considered qualified if he has previously completed a course in a school, an apprenticeship course, or a course of on-job-training which qualified thim for the job objective he makes application for...

DEATH COMPENSATION... The income of widows who receive VA death Compensation or Indemnity benefits does not effect their entitlement to these payments. These benefits are paid only if the serviceman or veteran died from a condition connected with his service in the armed forces. Some misunderstanding arises from time to time in this regard because the income of widows in receipt of VA death Pension whose husband died of non-service-connected causes does have to be reported.
