Andrea went over what had transpired the previous Monday when recyclables were caught on video by a resident being thrown into the trash. She expressed her apologies and said that is not how they do business. The driver tried to take a short cut and it was wrong.

She also told the council about the recycling facility that Priority is building in Flint. They want to provide the best service possible here.

Pat Betcher had the same concerns about recyclables going into the garbage.

Council Member Roszczewski spoke about recycling.

Priority explained one truck goes around for the garbage and then a few ours later it may be the same truck after it dumps comes back to do the recyclables.

Council discussed why have recycling if it isn't going where it needs to go.

Mike Ogg reflected he has seem the same thing. Recycling being dumped into the same can than all put into the truck as garbage.
