- Chief Moulden will draft a letter to Jackson Township proposing to extend our current contract at the current rates until December 2020 when their current contract with Williamsburg ends and then negotiate new contracts with all Townships involved so that everyone is being paid the same rates.

Township Items

- Chief Moulden met with Sherri Scmarr (Clermont County CDBG Coordinator) and Jerrold Bradley (Our Architect) today to discuss moving forward on the Community Center Project. Paperwork to extend our building permit for 6 months until 12/29/2018 was submitted last week. Mrs. Scmarr is expecting to go out to bid mid to late July with a project completion date of December 31, 2018.
- The proposed 2019 Tax Budget was presented to the Board. Discussion continued regarding line-item appropriations not meeting current needs. The Board will finalize later. The Fiscal Officer will have the report with the projected income and expenditures required by the County at the next meeting.
