Deputy Mayor Kempf called the meeting to order at 6:30 pm with the Pledge of Allegiance.

APPROVAL OF MINUTES: Motion made by Del Plato to accept the April 13, 2023 minutes, second Garcia, carried.

Library: Written report sent in by Ahouse – installed new fence on south side of parking lot with 6" posts and 2x8 rails

Fire: Written report sent in by Borden – 7 calls for May, joint training going well, a rescue tech refresher class was held at station. New truck out to bid – bid opening June 8th, air packs to be inspected June 1st, Will be getting firemen's grounds ready for Olde Home Day. Reminder, the firemen's grounds are private property. Use must be obtained from the department-addressed to Matt Barkee.

Water: Written report sent in by Ahouse – located and repaired the recharge line at Lively Run stream bank behind the stone wall that was damaged in the flood. Repaired water meter on Knight St. New tap requested at bottom of County Road 150. Normal monthly reports and samples complete and given to health dept. Repair injection pump line. NYRW training. Shut off customer on Orchard St, turned one Cayuga St. Completed annual Water Quality Report, needs to be put on website.

Motion by Garcia to approve tap CR 150, second Del Plato, carried.

Sewer: Written report sent in by Ahouse – Extra pumping this month, to clean the cone and grease trap. Hunt's working on design for the drying beds, still waiting to hear from J Thompson. There was a plugged and partially collapsed sewer line on Main across from school. Normal sampling by Yaws and normal pumping by Brewer's.

Streets: Written report sent in by Ahouse – Flags are up on Main. PESH safety and harassment class at county highway dept. We have been getting rid of some of the compost pile, mowing and trimming in full swing. Replaced culvert pipe on Mechanic with two 42" pipes to match what NYSDOT has feeding us under 96A. Patched with binder for now, will pave Mechanic this

year with CHIPS funding. Sidewalk requests for this y ear – Fitness Station, could run 12.5 yards if they want to replace it all including the footer. Second sidewalk AlarmTech Railroad Ave 4.5 yards.

Motion by Garcia to approve both sidewalks, second Del Plato, carried.

Police:

Jake brake complaints, NY State Police would send troopers close to village limits, upon hearing jake brakes, they will pull them over and inspect and warn them. SF police dept. taking electronic evidence for destruction to Erie Co. SAM.gov for IPD needs to go through Village account. Spring range was completed. State audit completed. IPD server issues – tickets/Tracs. Charger back in service. Old duty guns returned – sent back to Amchar for credit. 4 new holsters ordered. IPD asked to participate in Ovid Strawberry Festival June 17th. Narcan in vehicles. IPD awarded the Edward Bryan Memorial Justice Assistance grant \$7350.00 Olde Home Day: NY State 33-C permit approved, NY State Police will be sending one Trooper, Covert Highway will provide dump truck to block roadway.
