NOW THEREFORE BE IT RESOLVED THAT Hay Lakes Council endorses this 988 crisis line initiative; and that Staff be directed to send a letter indicating such support to the local MP, MLA, Federal Minister of Health, CRTC (Canadian Radio-Television and Telecommunication Commission) and local area municipalities to indicate our support.
