- Bart met with a representative from Fish & Wildlife who advised on placement of the deer exit gates. Jim will look into property and easement issues. Bart will meet with Ed Kamphaus to finalize gate and berm details, then okay the fabrication for a late March installation.

- Larry gave an update on the past month's activity involving the ADC. Board members received a copy of the monthly report.
- Larry reports a potential of five new construction starts this year.
- A previously approved application was suspended until the account is brought current.
- An owner was contacted about overly bright exterior lighting.
