Water Tank Change Orders 2 & 3 – motion by J Pepper to approve, second T Del Plato, carried

Water Sewer billing – letter to property owners stating they will be receiving their tenants water sewer bills starting with April 2020 cycle. Any unpaid water sewer balances on April 1, 2020 will be relevied onto their property tax bill. Motion by T Del Plato, second K Barr, carried

K Barr motioned to but out the life expectancy use of the current street light fixtures (\$2,431.55) in order to replace them with 3,000 Kelvin LED lights, second C Kempf, carried. This change could save upwards of \$6,000.00 per year. NYSEG to draw up a contract and Village Attorney Krogh review it.

Records Management Grant – Mayor Richardson will email Joe Borst (Town of Ovid) to learn about the grant Ovid was awarded. C Lysiak to pursue application for the 2021 January deadlines.

K Barr contacted Village of Watkins Glen regarding murals. He is waiting to hear back from them
